# Re: Testimony on Senate Bill No. 66, S.D. 1, Relating to the Code of Ethics

Hearing: March 11, 2013, 2:00 p.m. State Capitol, Conference Room 325

Testimony From: Hawaii State Ethics Commission

The Honorable Angus L. K. McKelvey, Chair; The Honorable Derek S. K. Kawakami, Vice Chair; and Honorable Members of the House Committee on Consumer Protection and Commerce:

Thank you for the opportunity to testify on Senate Bill No. 66, S.D.1, Relating to the Code of Ethics. The Hawaii State Ethics Commission ("Commission") <u>supports this bill</u> and also recommends that the bill be amended to require that the members of three state boards in addition to those identified in the bill file annual financial disclosure statements with the Commission that are available to the public for inspection.

The current law, HRS section 84-17, requires "members of every state board or commission whose original terms of office are for periods exceeding one year and whose functions are not solely advisory" to file an annual financial disclosure statement with the Commission.<sup>1</sup> However, as Senate Bill No. 66, S.D. 1 recognizes, the financial disclosure statements of members of the majority of state boards and commissions having significant authority currently are <u>not</u> publicly available.

The members of the boards and commissions that are the subject of Senate Bill No. 66, S.D.1 are described as having "official authority that includes approving, issuing, or renewing permits or licenses relating to land use, water use, or the regulation of public

utilities."<sup>2</sup> The Commission believes that, in addition to those state boards, the requirement for the public disclosure of financial disclosure statements should apply to three <u>additional</u> state boards: the Board of Regents of the University of Hawaii, the Hawaii Labor Relations Board, and the Labor and Industrial Relations Appeals Board.

The Board of Regents of the University of Hawaii exercises control over the internal structure, management, and operation of the University. Currently, the president, the vice presidents, the assistant vice presidents, the chancellors, and the provosts--all of whom are <u>subordinate</u> to the Board of Regents--are required to file <u>public</u> financial disclosure statements,<sup>3</sup> whereas the financial disclosure statements filed by the <u>members of the Board of Regents</u> are <u>confidential</u> and not available for public inspection. Therefore, the financial disclosure statements of the Board of Regents should be made public.

The Hawaii Labor Relations Board and the Labor and Industrial Relations Appeals Board each is a state agency vested with significant adjudicatory and/or regulatory authority whose members are full time, paid, state employees. Currently, the financial disclosure statements filed by the members of each of these boards are <u>confidential</u> and not available for public inspection. Therefore, the financial disclosure statements of members of the Hawaii Labor Relations Board and the Labor and Industrial Relations Appeals Board should be made public.

The primary purpose of the financial disclosure law is to provide transparency into the financial interests of legislators, state officials, state employees, and state board members to help identify potential conflicts of interests. The Commission receives almost 1,800 financial disclosure statements annually, the vast majority of which are confidential. By law, less than 200 financial disclosure statements are accessible by the public. Unfortunately, due to the Commission's limited resources and, in many cases, lack of complete understanding as to a person's official duties, the Commission's ability to review all financial disclosure filings and to determine whether a person has a conflict of interest

may be quite limited. For that reason, generally, the public is the best and most effective means to identify possible conflicts of interest.

Accordingly, the Commission recommends that the language of Senate Bill No. 66, S.D. 1 be amended as shown below. The Commission's proposed additional language appears in bold font and is underscored in bold. The Commission's proposed deleted language is lined out and is bracketed in bold.

SECTION 2. Section 84-17, Hawaii Revised Statutes, is amended by amending subsection (d) to read as follows:

"(d) The financial disclosure statements of the following persons shall be public records and available for inspection and duplication:

- (1) The governor, the lieutenant governor, the members of the legislature, candidates for and delegates to the constitutional convention, the trustees of the office of Hawaiian affairs, and candidates for state elective offices;
- (2) The directors of the state departments and their deputies, regardless of the titles by which the foregoing persons are designated; provided that with respect to the department of the attorney general, the foregoing shall apply only to the attorney general and the first deputy attorney general;
- (3) The administrative director of the State;
- (4) The **board of regents, the** president, the vice presidents, the assistant vice presidents, the chancellors, and the provosts of the University of Hawaii;
- (5) The members of the board of education and the superintendent, the deputy superintendent, the state librarian, and the deputy state librarian of the department of education;

- (6) The administrative director and the deputy director of the courts;
- (7) The administrator and the assistant administrator of the office of Hawaiian affairs[-]; and
- (8) The members of the following state boards [or] and commissions that have official authority that includes approving, issuing,or renewing permits or licenses relating to land use,water use, or the regulation of public utilities, including but not limited to the following:
  - (A) Board of directors of the agribusiness development corporation established under section <u>163D-3;</u>
  - $\frac{(B)}{26-16}$  Board of agriculture established under section
  - (C) Board of directors of the Aloha Tower development corporation established under section 206J-4;
  - (D) Hawaii community development authority established under section 206E-3;
  - (E) <u>Hawaiian homes commission established under</u> section 26-17;
  - (F) Board of directors of the Hawaii housing finance and development corporation established under section 201H-3;
  - (G) Board of land and natural resources established under section 171-4:
  - $\frac{(H)}{205-1}$
  - (I) Legacy land conservation commission established under section 173A-2.4;

- (J) Natural area reserves system commission established under section 195-6;
- (K) Board of directors of the natural energy laboratory of Hawaii authority established under section 227D-2;
- (L) Board of directors of the Hawaii public housing authority established under section 356D-3;
- (M) Board of directors of the public land development corporation established under section 171C-3;
- (N) Public utilities commission established under section 269-2; [and]
- (0) Commission on water resource management established under section 174C-7;["]
- (P) Hawaii labor relations board established under section 89-5(a); and
- (Q) Labor and industrial relations appeals board established under section 371-4."

Given the underlying purpose of the State Ethics Code to foster public confidence in state government, the Commission believes that allowing public review of the financial disclosure statements filed by the members of state boards and commissions having significant authority is consistent with that purpose.

# **DESCRIPTION:**

This measure proposes to extend to members of state boards and commissions, including members of the Public Utilities Commission ("Commission"), the requirement under Section 84 17(d), Hawaii Revised Statutes, that financial disclosure statements made to the State Ethics Commission also be deemed public records and be made available for "public inspection and duplication."

# **POSITION:**

The Commission would like to offer the following comments for the Committee's consideration.

# COMMENTS:

The Commission supports the principle of open and transparent government, however, requiring some board and commission members to disclosure their personal finances publicly may discourage the most qualified candidates from participating in these roles.

Specifically for the Commission, the Commission would like to suggest for the Committee's consideration that Commissioners instead file with their current statutorily required financial disclosure statements an affidavit affirming that he or she does not have a financial interest in any business regulated by the Commission. The suggested

alternative may be a more focused and direct method of confirming the lack of potential financial conflicts for a Commissioner.
