- 2. Allow the gun stores to perform background checks ala Arizona. Eliminating registration and transferring background checks to the private sector will save enough money to put more police on the streets. We can stop monitoring the activities of law-abiding citizens and focus on the criminals.
- 3. Eliminate the need to obtain a concealed carry permit. If you can legally buy a firearm, you can carry it. What use is a firearm for self-defense, if you must leave it in a locked safe at home? In practice, HPD does not even grant carry permits to anyone other than LE personnel. The real law-breaker is the government that denies citizens their constitutionally-recognized right to bear arms.
