### RELATING TO GOVERNMENT

Chairs Evans and Hanohano, Vice Chairs Lowen and Cullen, and members of the committee, thank you for the opportunity to testify on S.B. 722, S.D 2.

The Office of Information Management and Technology (OIMT) supports the intent of S.B. 722, S.D. 2 and offers the following comments for consideration.

OIMT understands the need to properly inventory and manage the State's assets, including its land interests. As such, asset management is one of the seven functions of the Enterprise Resource Planning (ERP) system program that is currently underway with in the planning phase and led by the Department of Budget and Finance with support from OIMT and the Departments Accounting and General Services, Human Resources Development, Taxation, and Education.

As part of our comprehensive development and planning of the proposed ERP system, we determined the phases of modules for implementation based on immediacy of need and resource allocations. The asset management function is currently planned for deployment in fiscal year 2016 with the assumption that the program will receive full funding. The asset management module would encompass all the State's assets, including buildings, facilities, vehicles, systems,

equipment, and all land interests, public trust and otherwise. The ERP system will provide an enterprise-wide view of all assets and provide real-time data and information.

In order to comply with the intent of this measure, an interim solution with associated funding would need to be developed because no existing system has the requisite capabilities. Although an interim solution would provide relief, it would duplicate the efforts of the ERP asset management module, divert resources from the current priorities of DAGS and OIMT, and be in operational use for less than two years.
