SENATE BILL NO. 753, SD 2 RELATING TO AGRICULTURE

Chairpersons Wooley and Evans and Members of the Committees:

Thank you for the opportunity to testify on Senate Bill No. 753, SD 2. This bill authorizes the department of agriculture (HDOA) to dispose of lands and negotiate and enter into leases with the agribusiness development corporation (ADC). The bill also exempts non-agricultural parks lands disposed to ADC from section 166-8(b) (2) and (5), HRS. ADC supports this bill.

ADC's mission is to create a vehicle and process to make optimal use of agricultural assets such as land and infrastructure. This bill seeks to allow HDOA to lease lands under its control to ADC for the purpose of administering a cooperative and comprehensive agribusiness development program to provide options for farmers to access land, help create jobs in the agricultural industry, and reduce our state's dependence on imported foods.

While ADC supports any measure that can enhance the State's agricultural production, we defer to HDOA with regards to the specifics of how this disposition provision would be set up.

Testimony in OPPOSITION to SB 753 SD2 which allows the Department of Agriculture to **"dispose"** of any state-owned agriculture land that is not declared an agricultural park to the existing Agribusiness Development Corporation.

This is NOT a good bill for the people of Hawaii.

I support bills that would help small farmers to get long-term leases. I support food and farm bills that INCREASE the wholesome Hawaii-grown food that you and I can eat, and DECREASE the use of poisons, herbicides, and pesticides.

But on Kauai, ADC has already given leases to large agribusiness corporations such as Dow, Syngenta, Pioneer which do NOT grow food that you and I can eat. These are businesses that INCREASE use of poisons, herbicides, and pesticides. They do not sell their produce in our state so do NOT PAY General Excise Tax. They use their lands for chemical experiments, testing how much herbicide can be applied before the plants are killed.

ADC's purpose is SUPPOSED to be to make optimal use of agricultural assets for the economic, environmental, AND social benefit of the people of Hawaii. Please NOTE the "AND" – NOT any one of those three, but all THREE together. But ADC's actions on Kauai would seem to me to only target economic benefit (for whom?) and NOT environmental OR social benefit for the vast majority of people with no vested interests.

Land under ADC control is exempt from all statutes, ordinances, charter provisions, and rules of any governmental agency relating to planning, zoning, construction standards, development and improvement of land, and the construction of buildings..." (HRS 166-4 Park development)

Under ADC there is **no public auction process**, as is required for agricultural land under DOA or DLNR control. Therefore, SMALL FARMERS ARE UNABLE to bid for the use of state agriculture land.

I OPPOSE THIS BILL because it gives ADC too much power to act in the best interests of giant biotech agribusinesses and NOT in the best interests of us, the vast majority of people of Hawaii.

PLEASE do NOT pass this bill.

I urge you to oppose **SB 753 SD2** RELATING TO AGRICULTURE.

SB 753 SD2 allows the DOA (Department of Agriculture) to **"dispose"** of any stateowned agriculture land that is not declared an agricultural park to the existing ADC (Agribusiness Development Corporation).

Under HRS (Hawaii Revised Statutes) 171-2 definition, agriculture land under ADC's control is **not public land.**

HRS 171-2 "**'Public lands"** means all lands or interest therein in the State...**except:** (10) "lands that are set aside by the governor to the agribusiness development corporation; lands **leased to the agribusiness development corporation by any department or agency of the State...**"

Land under ADC control is exempt from all statutes, ordinances, charter provisions, and rules of any governmental agency relating to planning, zoning, construction standards, development and improvement of land, and the construction of buildings..." (HRS 166-4 Park development)

Under ADC there is **no public auction process**, as is required for agricultural land under DOA or DLNR control. Therefore, small farmers are unable to bid for the use of state agriculture land.

Since lands under ADC's control are not considered public land, ADC is not required to hold public auctions for available ag land but can directly negotiate leases for ag land.

On Kauai, ADC has given leases to large agribusiness corporations such as Dow, Syngenta, Pioneer.

ADC's purpose is to make optimal use of agricultural assets for the economic, environmental, and social benefit of the people of Hawaii.

Please oppose SB 753 SD2.

Hawaii's Thousand Friends, a statewide land and water advocacy organization, strongly opposes SB 753 SD2 that authorizes the DOA to dispose of lands and negotiate and enter into leases with ADC.

SB 753 SD2 is an exemption bill with a twist.

SB 753 SD2 grants DOA the authority to "disposed" of *non-agricultural park land*, which is **ALL** State owned land designated agriculture, to ADC. Once agriculture land is transferred to ADC's control that land shall be "...exempt from all statutes, ordinances, charter provisions, and rules of any governmental agency relating to planning, zoning, construction standards, development and improvement of land, and the construction of buildings..." (HRS 166-4 Park development)

Even worse lands under ADC control are no longer considered public lands.

Under HRS 171-2 Definition of public lands, lands under ADC are not considered public. "Public lands" means all lands or interest therein in the State...except: (10) "lands that are set aside by the governor to the agribusiness development corporation; lands leased to the agribusiness development corporation by ay department or agency of the State..." (HRS 171-2)

In other words under SB 753 SD2 the DOA could simply "dispose" of publically owned nonagricultural park land to ADC under which public lands will no longer be public land as defined in HRS 171-2 and will be exempt from all types of statutes, ordinances, charter provisions etc.

In addition, because agricultural lands under ADC are not public land ADC is no required to hold public auctions but instead can directly negotiate leases for agricultural land.

SB 753 SD2 is a land grab of agricultural land for the benefit of a few, as seen on Kauai where ADC has given leases to large agribusiness corporations such as Dow, Syngenta, and Pioneer at the expense of many local farmers who are unable to bid for state agricultural lands.

SB 753 SD2 is not in the interest in furthering the goals of more diversified agriculture with local crops being grown for local consumption and increasing food security. and must be held in committee.

SB 753 SD2 is no in the public's best interest and must be held in committee.

SB753 SD1: RELATING TO AGRICULTURE.

Department of Agriculture; Disposition of Lands; Agribusiness Development Corporation

Authorizes the department of agriculture to dispose of lands and negotiate and enter into leases with the agribusiness development corporation. Exempts non-agricultural parks lands disposed to the agribusiness development corporation from section 166-8(b)(2) and (5), HRS. (SD1)
