Re: S.B. No. 874 Relating to Workers' Compensation

I. OVERVIEW OF PROPOSED LEGISLATION

S.B. 874 proposes to amend Section 386-80, Hawaii Revised Statutes (HRS), which relates to qualified impartial physicians appointed by the director, by requiring the specialty of the physician to be appropriate to the injury being examined.

The Department supports this measure.

II. CURRENT LAW

Currently, Section 386-80, HRS, does not specify that a physician appointed by the director must be a physician whose specialty is appropriate for the injury being examined.

III. COMMENTS ON THE HOUSE BILL

The Department supports this measure.

Qualifying the specialty of the physician will ensure that a physician knowledgeable in the injury of the claimant will examine the claimant.
