The Hawaiian Humane Society strongly supports the passage of Senate Bill 8, Senate Draft I as it prohibits laypersons from performing certain surgical procedures without being licensed as a veterinarian pursuant to section 471-2 Hawaii Revised Statutes.

Surgical procedures should only be performed by licensed veterinarians as they can result in negative physical consequences and can be extremely painful thereby resulting in distress. Surgical births, or otherwise known as cesarean births, tail docking, ear cropping, and debarking are some examples of these procedures where, if performed improperly by a layperson, could cause serious pain and suffering to the animal. Also, various procedures require critical post-surgery care in order to ensure that the wounded area is not infected or otherwise compromised. As with all surgical procedures, there are inherent risks of anesthesia, blood loss, and infection to the animal in addition to the emotional distress.

In order to ensure that all animals are treated humanely in all aspects of their lives, it is incumbent for all surgical procedures to be performed by the licensed veterinarians as deemed qualified by statute.

Thank you for the opportunity to testify in support of SB 8, SD 1, relating to veterinary medicine. On behalf of the Hawaiian Humane Society, I ask for your support in passing this measure.

On behalf of our members and supporters of The Humane Society of the United States in Hawaii, we thank you for the opportunity to speak in strong support of SB8; Relating to Veterinary Medicine.

This important measure would prohibit unlicensed veterinarians and non-veterinarians from performing cruel surgical procedures on pet animals, and set forth appropriate criminal penalties. This bill is necessary as our current animal cruelty law exempts "cropping and docking as customarily practiced" but does not require that these procedures be performed by a professional licensed veterinarian. This law only applies to pets, not farm animals.

Ear cropping, tail docking, declawing, debarking and any other surgical procedure is extremely painful to an animal if proper pre and post-operative care and anesthetic are not administered. Non-veterinarians performing these procedures often forcefully restrain and bind the dogs with duct tape, then use razor blades, box-cutters or simple scissors to cut the dogs' ears and/or tail.

Ear-cropping by non-veterinarians is also a common procedure performed on dogs prepared for and used in illegal dogfighting to prevent bleeding from torn and ripped ears, which may compromise the dogs' vision and ability during a fight.

Unfortunately, we have seen many cases where individuals (non-veterinarians) have attempted to perform such procedures on pets, resulting in extreme suffering. In addition, if not performed by a professional veterinarian, these procedures can result in serious infection, blood loss, shock and even the death of the pet.

We respectfully urge your support of this measure.

Subject: SUPPORT FOR SENATE BILL No. 8

Honourable Chair and Members of the Committee.

I have mixed emotions on this Bill, having owned dogs that had docked tails and clipped ears for many years. Today, when I see dogs of this breed without them they look strange to me. However, many dog associations, especially in Europe have agreed that unless the docking of the tail is required for the performance of the duties of the dog, they should no longer be docked. I note the following legislation from England, where most dog clubs originated.

1. The current law is set out in section 6 of the **Animal Welfare Act 2006** and in the Docking of Working Dogs' Tails (England) Regulations 2007 (SI 2007/1120).

In brief, the Act makes it an offence to remove the whole of part of a dog's tail other than for the purpose of medical treatment, subject to the exemption for docking the tails of certain working dogs. In particular, the legislation states:

a. that any veterinary surgeon who docks a tail must certify that she/he has seen specified evidence that the dog is likely to work in specified areas;

b. the dog must be no older than five days and will need to be micro chipped;

c. the types of dog that may be docked; and

d. the types of evidence which the veterinary surgeon will need to see

Most dogs do not need their tail docked for any reason, but if they must for working purposes, it should be done by a veterinary surgeon.

I would recommend support for this bill.

Testimony for SB 8 SD 1

My name is Lynn Muramaru and I am a breeder/exhibitor of Miniature Schnauzers, a breed that is shown with dew claws removed, tails docked, and typically with cropped ears. I have also owned dogs that were debarked and have had c-sections so I am very familiar with all the procedures that this bill addresses. Most of the dogs I have purchased on the mainland have had dew claws removed, tails docked, and ears cropped by persons who were not veterinarians. As a lifelong animal lover and a dog breeder for over 20 years, the health and welfare of ALL animals has my utmost priority.

I do not oppose this bill in its entirety. I would like to propose an amendment to this bill that would separate out the 2 procedures of dew claw removal and tail docking and allow breeders (non-veterinarians) to continue to perform these procedures if done before 5 days of age. Any procedure to be done after 5 days would require the services of a veterinarian.

I would like to propose another amendment that would allow a non-veterinarian who is skilled at ear cropping to perform this procedure until the supervision of a veterinarian. This would allow breeders from the mainland to come to Hawaii to teach interested veterinarians how to produce an ear crop that is consistent with a particular breed standard.

- I have attempted an informal survey of every veterinary clinic on Oahu, Maui, Hawaii, and Kauai.
 I was able to identify about 80% of the clinics on Oahu and close to 90% on the neighbor islands.
 Clinics were surveyed to see if they perform dew claw removal, tail docking, ear cropping, and debarking. Passing this bill as written ASSUMES that every veterinarian performs each of these procedures and the services are reasonable accessible. This is NOT the case. See attached file.
- 2) New born puppies are born under developed. Ears and eyes are sealed shut and nerve endings are under developed. My litters of puppies had dew claws removed and tails docked by a vet at around 2 to 3 days of age before the nerve endings have a chance to develop. There were occasions when a pup might not have been stable enough to have the procedure done with its littermates. That would necessitate an additional trip to the vet. These trips to the vet expose very young pups (4-8 ounces depending upon breed) to the stress of travel and highly contagious diseases like parvo virus.



3) Dew claw removal & tail docking done before 5 days of age is done without anesthesia and does not require a sterile surgical suite. It only requires a clean working surface. No blood or extremely little is involved. I have witnessed this procedure many times. Dr. Eric Ako attested to this fact at the hearing for HB 140 (the companion bill).

4) There is a time constraint of no more than 5 days in which to do docking and dew claw removal. This is a very small window of time and when you factor in holidays, weekends, and busy veterinary practices, this does not leave a person very time to get a litter an appointment.

Regarding ear cropping:

- 1) The best examples of tail docking and ear cropping I have seen for my breed were done by breeders themselves. Correct docking and cropping is an art form requiring more than just surgical skill. Only a breeder can best estimate projected adult proportions so that tails and ears are in balance once a dog hits maturity. I do not perform these procedures myself but I have had breeders who were skilled come to Hawaii to teach local veterinarians how to do these techniques. Currently there are 20 breeds that are cropped and 62 breeds where tails are docked. There is no way for a veterinarian to know the particular nuances for all these breeds! http://images.akc.org/pdf/canine_legislation/Crop-Dock-Debark-Article.pdf Additional information regarding these procedures.
- 2) There are **only about 12 veterinarians statewide who do ear cropping** and a few offices told me they only know how to do about 2 different breeds.

A bill such as this **would do more harm to the preservation of pure bred dogs** by destroying what we refer to breed type. We ought to know at a glance that this dog is a schnauzer and that one is a poodle, etc. We should not have to guess.

Thank you for allowing me to provide testimony that I hope will guide you to making the right decision.

Dear Chair Hee, Vice-Chair Shimabukuro, and Committee Members

We do not oppose this bill in its entirety. However, we do believe that, in the case of dew claw removal that the procedure should be allowed to be performed by non-veterinarians if accomplished prior to five days of age.

Our breed, the Chinese Shar-Pei dog is shown with dew claws removed, otherwise unaltered. Our Master Breeders, and many veterinary technicians, currently perform the procedure. In fact, most of us prefer the procedure be done at the whelping box, close to mom, with little interruption to the new born puppy's routine.

Our new born puppies are born both blind and deaf and are not able to regulate or maintain their body temperature. They are totally dependent on mom and human assistance, if necessary, to begin their life process. Taking them away from mom at 48 hours of age, just as they are developing a regular nursing protocol, to a vet office to have their dew claws removed is unnecessarily harsh for both mom and puppies. Moreover, trips to the vet expose our new tiny under developed puppies to the stress of travel and highly contagious puppy killing diseases such parvo.

Furthermore, dew claw removal done before five days of age is done without anesthesia and does not require a sterile surgical environment. It only requires a clean instruments and proper after care. In fact, the tiny little dew claw is so soft that usually a single "snip" will remove it. No blood or very little is involved. I have witnessed this procedure many times, and I know of no complications from the removal of our puppy dew claws over the past 20 years.

In our opinion, SB 8 as submitted should be amended as suggested by, not only our club members, but also breeders of other breeds who may require additional newborn procedure.

We urge your committee not to adopt SB 8 in its current rendition.

Comments: Dogs have dewclaws and tails docked for a reason. I ask that dog owners be allowed to remove their own tails and dewclaws if the puppy is 5 days old or less. Exposing young pups to a vet clinic at that age puts them at UNNECESSARY risk of contracting deadly illnesses. In the UK and down under, dewclaws are left on causing adult dogs used for field, I.e. cattle herding, hunting to more unnecessary pain if those dewclaws get caught on something and torn. Some responsible dog breeders also prefer to take off tails at less than 3 days old because they are more accurate at making sure the length is correct and meets their breed standard as an adult. Please consider amending this bill to allow the pup owners to remove their own sews and tails if puppies are 5 days old or less.

Comments: Dear Committee: I am writing in support of SB8. As a licensed veterinarian, I believe only veterinarians are properly trained to perform humane and safe surgical procedures on animals. Not only do veterinarians go through rigorous training to develop proper surgical skills, they also possess the knowledge of proper drug use in animals and safe anesthetic protocols. SB8 ensures that our pets are cared for by those with the appropriate knowledge and skills. Any surgical procedure on an animal performed by a non-veterinarian is highly likely to be in a non-sterile environment with inadequate tools, anesthesia, and medication, and will NOT provide a safe and humane procedure for the animal. Most remember the KITV expose of the Pearl City man who admitted to doing ear crops, spays, and castrations on dogs in 2010. Unfortunately no legal action could be taken against him to prevent him from continuing to do these procedures, because a law such as SB8 was not in place. In practice, I have seen multiple cases of pit bull and doberman puppies with infected ears from poorly done ear crops (sutures obviously too tight, infected surgery sites, too much of the ear cropped). All of these owners will not say who performed the "surgery", which raises my suspicion of nonveterinarians performing these procedures.
