PURPOSE: S.B. 91, S.D.1, appropriates funds for the state rent supplement program, for homeless working individuals or families who are ready to rent permanent housing in order to obtain and maintain permanent housing.

DEPARTMENT'S POSITION: The Department of Human Services supports the intent of this measure as it creates a vehicle for working homeless individuals and families to secure and maintain permanent housing, but we are concerned about the cost implications and the adverse impacts on the priorities in the Executive Biennium Budget.

The proposed rent supplement program could be accessed by individuals and families who are currently living in homeless transitional shelters. Many of these people are employed but do not make enough money to afford market level rentals. Currently, Public Housing may seem like the only alternative these individuals and families have to meet their need for permanent, affordable housing. But with a public housing waitlist that spans many years, this target population needs another avenue to secure affordable,

permanent housing. A modest rent supplement of up to \$300 per month as proposed in this bill would help these individuals and families secure and maintain themselves in permanent housing.

The DHS respectfully requests that should this bill be approved, the expending agency should be the DHS rather than the Hawaii Public Housing Authority.
