#### in consideration of SB 937 SD 1 RELATING TO HAWAII FOOD RESILIENCY.

Chair Ige, Vice Chair Kidani and Members of the Senate Committee on Ways and Means.

The Office of Planning has the following comments on S.B. 937 SD 1 Relating to Hawaii Food Resiliency. S.B. 937 SD 1 proposes a food resiliency initiative program to reduce Hawaii's dependence on imported foods.

The *Increased Food Security and Food Self-Sufficiency Strategy* prepared by the Office of Planning (OP) in cooperation with the Department of Agriculture seeks to increase the amount of locally grown food consumed by Hawaii residents, increase the production of locally grown food and recommends policy and organizational support toward food self-sufficiency. According to a College of Tropical Agriculture and Human Resources, University of Hawaii study, food import replacement has positive economic impacts including retaining money in the state which has a multiplier effect, and increasing tax revenues and jobs.

OP defers to the Department of Agriculture on the establishment of a program and positions and the appropriation of funds for a food resiliency initiative program.

## TO CHAIRPERSON DAVID IGE AND MEMBERS OF THE COMMITTEE:

The purpose of SB 937 SD 1 is to, among other things, establish a food resiliency branch within the Department of Agriculture.

The Department of Human Resources Development has no position on the outcome of this bill, but offers **comments** regarding the establishment of a food resiliency administrator and staff. We recommend that the exemption of these positions from civil service be discretionary instead of mandatory, and recommend the following replacement language be used.

Page 9, lines 20 and 21:

"The position shall be a full-time position that may be exempt from chapter 76." Page 10, line 7:

"The positions may be exempt from chapter 76."
