SENATE CONCURRENT RESOLUTION 105 / SENATE RESOLUTION 71 AUTHORIZING THE ISSUANCE OF A TERM, NON-EXCLUSIVE EASEMENT COVERING A PORTION OF STATE SUBMERGED LANDS AT MAKAHA WAIANAE, OAHU, FOR THE USE, MAINTENANCE, AND REPAIR OF AN EXISTING SEAWALL

Senate Concurrent Resolution 105/Senate Resolution 71 request the authorization to issue a term, non-exclusive easement covering 131 square feet, more or less, portion of state submerged lands fronting the property identified as tax map key: (1) 8-4-005: seaward of 002, at Makaha, Waianae, Oahu for maintenance and repair of existing seawall constructed thereon, pursuant to Section 171-53, Hawaii Revised Statutes (HRS). The Department of Land and Natural Resources (Department) supports these resolutions.

The owner of the abutting property, West Coast Roofing, Inc., was in the process of obtaining a shoreline certification. During the survey process, portion of the seawall was found encroaching on State lands located makai of the shoreline and therefore considered submerged lands. As required by Section 171-53, HRS, the Board of Land and Natural Resources (Board) may lease submerged lands "with the prior approval of the Governor and the prior authorization of the Legislature by concurrent resolution". At its meeting on January 11, 2013, under agenda item D-14, the Board approved the issuance of a new term, non-exclusive easement for seawall purposes.

The Department notes that the tax map key in the second paragraph of this concurrent resolution should be amended to "(1) 8-4-005:seaward of 002".

The Lessee is required to pay the State the fair market value of the easement as consideration for the use of public lands. The amount of consideration is to be determined by independent appraisal.
