In consideration of SENATE CONCURRENT RESOLUTION 164 REQUESTING THE GOVERNOR TO ESTABLISH A WORKING GROUP TO DEVELOP A CONSERVATION ACTION PLAN TO EXPLORE AND IDENTIFY CONSERVATION ALTERNATIVES FOR THE UNDEVELOPED PORTIONS OF THE TURTLE BAY HOTEL AND RESORT PROPERTY AND SURROUNDING LANDS WITH CONSERVATION OR HISTORIC VALUE.

Senate Concurrent Resolution requests the Governor to establish a working group to develop a conservation action plan to explore and identify conservation alternatives for the undeveloped portions of the Turtle Bay Hotel and Resort property and surrounding lands with conservation or historic value. The Department of Land and Natural Resources (Department) strongly supports this resolution.

The Department supports the protection of the area as it is one of the last undeveloped areas on O'ahu, recognized for its rock formations, wild coastal beaches, threatened green sea turtles and endangered Hawaiian monk seals habitats, whale spotting, traditional fishing areas, small local agricultural lots, and Hawaiian ancestral burial grounds. Act 140, Session Laws of Hawaii 2008, authorized the Governor to negotiate on behalf of the State with private interested parties to purchase the resort property located in Kahuku, Oahu. Having the Governor establish a working group to develop a conservation action plan would greatly aid in these negotiations.

The Department also supports \$100,000 provided in the Senate version of the budget bill (House Bill 200) relating to appraisals and other studies for Turtle Bay. These funds are necessary to develop the conservation action plan for Turtle Bay. It is the Department's understanding that legislators whose districts may include the Turtle Bay Resort may be requesting \$5 million in general obligation bonds to explore the viability of purchasing a conservation easement that would help to preserve this area from future development. The Administration has been in preliminary discussions with these legislators and some members of the community. Should the Legislature fund this request, the Administration would be supportive.
