Honorable Chair Hee and committee members:

I am Kris Coffield, representing the IMUAlliance, a nonpartisan political advocacy organization that currently boasts over 150 local members. On behalf of our members, we offer this testimony <u>in strong support of</u> SR 123 and SCR 166, relating to marriage equality.

As advocates for social equality and civil rights, we fully support measures that move Hawaii toward instituting marriage equality. While we are saddened that the State Legislature decided not to hear, much less advance, a bill legalizing same-sex marriage during the 2013 legislative session, we are confident that the task force called for by this bill will conclude that marriage equality will have a positive impact on Hawaii. We note that a 2013 report prepared by University of Hawaii economist Sumner La Croix found that legalizing same-sex marriage would inject \$46 million to \$258 million into Hawaii's economy. More importantly, such a law would end discrimination against into same-sex couples, whose attraction to one another has been shown to be primarily based on biological and developmental factors-the basis for relationships and attraction, no matter what they may be, should not be used a barrier to expanding civil rights. Put simply, institutionalized religion should not trump individual rights when it comes to enacting just public policy. That said, we encourage the committee to include the Attorney General or Attorney General's designee, Department of Taxation or DoTax's designee, and Chair of the Hawaii Civil Rights Commission or chair's designee to the list of task force members, thereby ensuring that the executive's legal, financial, and labor rights expertise is represented in considerations of the sensitive issues involved in marriage equality discussions.

Re: Social, Economic, and Religious Impacts of Enacting Marriage Equality in Hawaii

As a Master's Level Social Worker, I strongly oppose SR 123 and SCR 166 for Social, Economic, and Religious Impacts of Enacting Marriage Equality in Hawaii on the grounds that further studies are unnecessary because there are standing studies that already address the issues named in these resolutions and will cost Hawaii funds that are so badly needed for other state requirements: education, help for the homeless and additional budgetary items.

1) Hawaii has a history of studies already completed, such as the **1995 Blue Ribbon Panel** commissioned by former Governor Ben Cayetano on Same Gender Marriage that found no inherent harm would be done to Hawaii when social justice would be reality for our GLBT community. I have a gay son who deserves the same marriage rights that my husband, Mike and I have enjoyed for the past 47+ years. http://www.nytimes.com/1995/12/11/us/panel-in-hawaii-recommends-legalizing-same-sex-marriage.html

There is the 1996 study by the Hawaii Council of Churches that states

a) the Jewish tradition (1996, the Annual Convention of the Central Conference of American Rabbis resolved to the support the right of gay and lesbian couples to share fully and equally in the rights of civil marriage, "oppose governmental efforts to ban gay and lesbian marriage," and further that "this is a matter of civil law, and is separate from the question of rabbinic officiation at such marriages.");

b) the Buddhist (Buddhist principles which would serve to show that same gender relationships and the rights that follow from them, such as marriage, can be positive in assisting a person to discover their own true nature and to realize the depth of their spiritual potentiality.");

c) the United Church of Christ General Synod (declares its support for the enactment of legislation at the federal, state, and local levels of government that would guarantee the liberties of ail persons without discrimination related to affectional or sexual preferences.");

d) the Episcopal Church (1976 affirmed that "homosexual persons are entitled to equal protection under the law.; in 1991 reaffirm w/further resolution 'upon municipal councils, state legislatures and the United States Congress to approve measures giving gay and lesbian couples protection such as: bereavement and family leave policies, health benefits, pension benefits, real estate transfer tax benefits, and commitments to mutual support enjoyed by non-gay married couples.");

e) The United Methodist Church (Book of Discipline 1992: "Certain basic human rights and civil liberties are due all persons. We are committed to support those rights and liberties for homosexual persons.');

f) The General Assembly of the Christian Church (Disciples of Christ) (urge(s) the passage of legislation on local, state and national levels which will end denial of civil rights and the violation of civil liberties for reasons of sexual preference, and calls upon ");

g) The Unitarian Universalist Association ('1996 General Assembly "in support of the legal recognition for marriage between members of the same sex;" and urging its "member congregations to proclaim the worth of marriage between any two committed persons and to make this position known in their home communities.");

h) The Presbyterian Church ("recognized that committed same-sex partners seek equal civil liberties in a contractual relationship with all the civil rights and privileges and status of married couples." The General

Assembly further urged the office of the Stated Clerk to explore the feasibility of entering friend-of-the-court briefs and support legislation in favor of giving civil rights to same-sex partners.");

3) There is the **2010 UCLA "Economic impact of allowing same-sex marriage in Hawaii"** that addresses the economic impacts.

4) There is the **2013 American Academy of Pediatrics study** (AAP) The AAP policy statement, "Promoting the Well-Being of Children Whose Parents Are Gay or Lesbian," which supports civil marriage for same-gender couples – as well as full adoption and foster care rights for all parents, regardless of sexual orientation – as the best way to guarantee benefits and security for their children. This is a professional study with empirical data that address the social issues of adoption and foster care for the best interest of ALL our keiki and their families.

In the beginning of the 1990's Hawaii started a journey for Civil Rights, Social Justice started in Hawaii. Other states dreamt about it but Hawaii did something about it. There was the

It is said in "Same-Gender Marriage and Religious Freedom" by the Rev. Dr. C. Welton Gaddy President, Interfaith Alliance:

While I do believe that an issue such as marriage equality, which would provide federal benefits to families like ours, should not have to resort to the need for a task force, I am in support of this resolution if it will assist in creating a better understanding of particular issues surrounding the passage of marriage equality legislation here in our home state of Hawaii.

It would be my hope that this task force would yield an outcome that gives legislators the justification and confidence that they are standing on the right side of this historic civil rights issue. As we can see, the world is moving in the right direction and it does seem that in the near future marriage equality will be part of our everyday life and I look forward to the day when that will happen.
