Not that long ago most blind children were educated at residential schools for The blind, Where the children play together which help develop leadership qualities.

Here in Hawaii Blind children are isolated from the opportunity to meet other Blind children in our community and a playground would Make it possible where they can have social interaction .

Social interaction as we all are awear of is important in the development of learning Builds healthy body working their muscle, bone, develop balance and stimulates their Desire to explore and broaden their sensory perspective.

The mind's eye has a mental view but having tactile experiences gives you a better perspective. and helps develop confidence and a sense of competition.

Children need to touch a variety of textures and play with them to develop normal tactile processing.

Sensory activity equipment would need to be installed.

#### **Example Play Tunnels And Tents:**

Both of these have many uses as part of sensory integration activities.

The following are just some of the ways to use them...

use the tunnels as an active *gross motor and bilateral motor coordination activity* just by having the child crawl through them.

create a *tactile experience* by placing different textured objects or carpet squares inside the tunnel.

These activities are almost endless in choices. *Proprioception refers to input to the muscles, joints, ligaments, tendons and connective tissue*. It refers to motor control and planning, body awareness, grading of movement (knowing how "hard" or "soft" to perform a task), and postural stability.

# If the proprioceptive sense is not working well, it will be difficult to move in smooth, coordinated, and properly graded movements.

use play tents as a *safe haven for children who are overwhelmed by sensory stimuli* or as *a sensory controlled environment* resting or reading. we can place bean bags, headphones with relaxing music inside for a relaxing environment)

There can be a section with instruments such as wooden blocks, symbols, tri angles, etc. so they can have a

jam session with their new friends. other things like Slides, Big balls, sand box and so on.

A playground would be place to make new friends with peers instead of being the only Blind person in a group setting.

A playground would not only be wonderful for Blind Children but also for the parents and families Who will socialize and learn and from each other issues and give support to each other. Which can make a difference in a Childs life.
