## RE: SCR 41 REQUESTING THE EXTENSION OF THE GOVERNMENT CONTRACTING TASK FORCE

Chair Dela Cruz, Vice Chair Slom, and Members of the Committee:

The Chamber of Commerce of Hawaii ("The Chamber") supports SCR 47 Requesting the extension of the government contracting task force.

The Chamber is the largest business organization in Hawaii, representing more than 1,000 businesses. Approximately 80% of our members are small businesses with less than 20 employees. As the "Voice of Business" in Hawaii, the organization works on behalf of its members, which employ more than 200,000 individuals, to improve the state's economic climate and to foster positive action on issues of common concern.

SCR 41 extends the task force to June 30, 2013. We also support the additional requirements of:

- Examining and reporting on the state contracting processes, from the initial planning phase through service delivery, and issues relating to payment when invoices are submitted;
- Make recommendations on processes that can be simplified and standardized between government agencies, the State Procurement Office, the Department of Accounting and General Services, the Department of the Attorney General, and the parties contracted to deliver services; and
- Evaluate the "dashboard" demonstration project that utilizes designated contract areas in the Department of Health, Department of Human Services, and Department of Public Safety to test business process improvements or other approaches and make recommendations to streamline the contracting process, with the goal of clarifying problem areas and solutions for government agencies and the parties contracted to provide services;

A recent nationwide Nonprofit State of the Sector study conducted by the California-based Nonprofit Finance Fund showed that those who received state or local funding experienced late payments by government.

The task force has been meeting since the summer of 2011 and has covered much ground in understanding the obstacles to prompt government contract payments to predominantly nonprofit health and human service providers through 103F contracts.

Due to the complexity of the issue and the fact that delayed payments are symptoms of larger systemic challenges; the task force requires more time to find solutions agreeable to all.

With a granted extension, task force discussions will continue to focus on the higher systemic issues that include contracting and payment processes, communication, technology, accountability, transparency, education and training for both government and providers.

The fact that many of the government contracting challenges are technology-oriented presents an opportunity to feed information to and align with the goals of the State's Chief Information Officer in his endeavor to modernize IT, business systems, HR and financial and tax systems for state government.
