Comments: Dear Honorable Senator Hee and Committee members, Approximately 64 percent of Hawaii households have a pet. A Zogby International poll found that 61 percent of pet owners will not evacuate if they cannot bring their pets with them, and as I witnessed first hand during Hurricane Katrina and other natural disasters. While our state emergency response plan complies with the federal Pet Evacuation and Transportation Standards Act in allowing pets and service animals to be included in response plans, it is still undetermined exactly how this will be carried out and what percentage of pet owning residents may refuse to evacate if their pet is unable to accompany them. In addition, there are hundreds of homeless persons on the West Side of Oahu and in other areas that have pets (earlier surveys suggests as many as 90 percent of homeless have pets in some areas) and their refusal to evacuate due to their pet and lack of transportation for their pet. We respectfully request your consideration of including pet owners living in residential areas and homeless persons with pets living in evacuation/inundation zones in the proposed study.
