My name is Celia Suzuki, Licensing Administrator for the Professional and

Vocational Licensing Division ("Division"), Department of Commerce and Consumer

Affairs. The Division appreciates the opportunity to submit comments on S.C.R. No. 94

and S.R. No. 60, Requesting the Division to Convene a Working Group to Consider

Streamlining or Consolidating any of the Licensing Boards and Commissions within the

Purview of the Division.

Testimony for S.C.R. No. 94 and S.R. No. 60 Wednesday, March 27, 2013 Page Two

The purpose of the two resolutions is to review and consider streamlining or consolidating any of the twenty-five (25) licensing boards and commissions within the purview of the Division, due to the preconception that the Division has a limited number of financial and human resources to successfully administrate all twenty-five (25) licensing boards and commissions. Currently, there are fourteen (14) Executive Officers who oversee the administrative responsibilities for the twenty-five (25) regulatory boards and commissions. Their main responsibility is to ensure the safeguarding of the general public's interest relative to the regulation of the various professions and vocations. They assist and advise the boards and commissions and arrange for and attend approximately 194 meetings each calendar year. These meetings have been proven to be manageable and well attended and carefully coordinated by all involved. The Division is able to maintain its current workload with the resources appropriated by the Legislature. Therefore, we do not believe these resolutions are necessary.

However, if the Legislature feels that it is vital for the Division to examine and review the structure of its twenty-five (25) licensing boards and commissions, then we would like to suggest that the Legislature request that the Office of the Auditor assist with this undertaking and have that office take the lead on these resolutions, as that office has the expertise and a proven track record in this area.
