Testimony in Support of SCR 96

Chairperson Takumi, Chairperson Choy, and Members of the House Committees on Education and Higher Education:

My name is Joanne Swearingen and I would like to testify in favor the SCR 96, Commending the Jump Start Task Force on the Creation of the Jump Start Program, Encouraging Expansion of the Program to Schools on the Islands of Maui and Hawaii, and Requesting the Department of Education and University of Hawaii Community Colleges to Continue Their Support of the Program.

My sons went to Hokulani Elementary School, Jarrett Intermediate School. One went to Kalani High School, graduating in 1999; the second son went to Kaimuki High School graduating in 2001. Both sons went to and graduated from Mainland colleges and found jobs in California, one as an IT innovative technology manager and the other as a high school counselor. When they return to Hawaii and visit with their local friends, many of their friends are in dead-end jobs and have not yet completed either a two year or four year college degree.

Since my retirement I have been volunteering to assist with the Jump Start Program because the participating high school principals and counselors and community college administrators and counselors have created a program that gives high school students a viable option in seeking careers in Career and Technical Education.

What is amazing to me is that expansion beyond the four original pilot high schools (Farrington, Kaimuki, McKinley and Farrington) and two community colleges (Honolulu and Kapiolani Community Colleges) has been at the request of Kauai and Leeward District high school principals and Leeward and Kauai Community Colleges. These educational institutions see that Jump Start is meeting a need for some of their students. Both the DOE Superintendent and the Community Colleges Vice President and Chancellors have also been very supportive of the Jump Start Program.

I strongly encourage you to pass SCR 96 so that high schools and community colleges on Maui and the Big Island may also choose to participate in this program to provide viable choices to their students.
