## **Session Highlights: The Budget**

At the start of the session, the primary challenge of the legislature was how to rectify a \$1.3 billion deficit, after facing and closing a \$2.1 billion deficit in 2009 and another \$1.2 billion in 2010.

As in 2009 and 2010, the legislature achieved a balanced budget this year through a combination of budget cuts and increasing revenue. Over half of the deficit was closed by making cuts to the state budget, and we avoided having to raise the general excise tax (GET) which would have seriously impacted every resident and business in the state.

#### **HB200:** Details of the State budget


The budget covers the next two years and appropriates \$5.4 billion in General Funds (\$11 billion in All Means of Financing) for FY2012, and \$5.5 billion (\$10.9 billion in All MOF) for FY2013. This state biennium budget is based on the Council of Revenues projection equating to a \$1.3 billion deficit. In order to close the gap, the legislature made over \$600 million in cuts, passed revenue generating bills totaling around \$600 million, and found over \$200 million in budget lapses and other adjustments.

Included in the cuts are labor savings of \$88.2 million in each year of the biennium due to state workers taking a 5% pay cut. In addition, the legislature passed **HB575 Extension of salary cuts** which extended a 5% pay cut for state legislators, judges, the governor, lieutenant governor, and department heads and deputies.

## **Addressing Economic Challenges**

Some of the major budget and tax revenue bills passed this session include:

SB120 Non-general fund transfers- Transfers \$40 million from special funds to the general fund.

<u>SB570 Tax deduction</u> - Eliminates the state tax deduction for high income individuals, temporarily limits itemized deductions for high income individuals, and delays the standard deduction increase for low-income filers. Generates \$113.5 million.

<u>SB754 Repeal GET exemptions</u> - Repeals various GET business exemptions for 2 years. Generates \$393.5 million.

<u>SB1186 TAT and HTA Cap</u> - Caps the counties' share of the Transient Accommodations Tax (TAT) until 2015 generating \$40.4 million. Caps the TAT going to the Hawaii Tourism Authority generating \$34.9 million.

<u>HB1039 Rental Vehicle Surcharge</u> - Increases the rental vehicle surcharge. The first year of the increase goes to the General Fund. Generates \$60 million.

### **Funded projects in our District**

More than 50 Capital Improvement Projects (CIP) have been initiated as part of the Governor's New Day Works Projects to create jobs and stimulate the economy. More than \$300 million will be infused in our local economy for projects, which include modernizing our airports, schools, and repairing roads and infrastructure. Kauai legislators fought hard to ensure many of these projects will be on the Garden Island.

## **Design work for Kuhio Highway to start**

Governor Neil Abercrombie has released Capital Improvement Project funds to begin the work on the Kuhio Highway, Retaining Walls at Lumahai and the Wainiha Phase 2 (Bypass Road). Phase 1 of the project will consist of slope stability analysis and roadway stabilization from Milepost 5.0 to Milepost 5.17 and Phase 2 to construct a new bypass roadway from Milepost 5.20 to Milepost 5.55. The first \$500,000 has been released to begin the design work. DOT estimates that the total project costs to be 4.5 million with an projected completion date of 2014.

## **Legislation protecting lifeguards, firefighters**

Representative Kawakami hit the ground running from the moment he was sworn in at the Hawaii State Capitol. He serves as the Vice Chair of the Energy and Environmental Protection Committee and is a member of the Finance Committee, Housing Committee, and Water, Land, and Ocean Resources Committee.

As the former President of the Hawaii State Association of Counties, Representative Kawakami requested legislation to protect our lifeguards and firefighters in the performance of their duties by increasing the penalties for assault on them to a class C felony. With the help of the House and Senate leadership, the Kauai County Council, Dr. Monty Downs President of the Kauai Lifeguard Association; and Fire Chief Robert Westerman of the Kauai Fire Department, the Representative was able to shepherd Senate Bill 1025 through its final passage.

"This measure is extremely important to the Counties and the State as it protects those who are in charge of protecting us," said Kawakami. "This is the least we can do for our local heroes."
