## **2013 LEGISLATIVE SESSION HIGHLIGHTS**

"The agreed upon budget appropriated more than \$172 Million for the Kahului Area" - Maui News

The Legislature approved bills that address the needs of a wide spectrum of the State's population. The approach this session was to focus on the State's long term needs such as reducing fiscal liabilities, repaying our reserve funds, promoting economic development, early education, sustainability and improving the quality of life for residents.

The fiscal years 2013-2014 State Budget responds to the pressing needs of Hawaii's people while carefully scrutinizing expenses and crafting an appropriate budget to ensure that the most significant priorities are met and to lend a structural stability to the State's financial plan.

The House of Representatives used a fresh approach of conducting business under the leadership of Speaker Joe Souki. ### **WOODSON SECURES \$172 MILLION FOR KAHULUI**

The Maui Delegation has a great working team in the House of Representatives. Under the Leadership of Speaker Joe Souki, and while working with Senate counterparts, Representative Justin Woodson was able to secure **\$172 Million** in this year's Hawaii State Budget; **50% higher** than the average amount secured in other areas.

# HIGHLIGHTS OF THE CAPITAL IMPROVEMENT PROJECTS FOR THE KAHULUI AREA

## \$50 Million for Kahului Airport

Funds for much needed improvements and land acquisition.

## \$22.7 Million for Maui Memorial Medical Center

These resources will be used for equipment upgrades, improvements to the imaging laboratory, and the oncology department.

### \$6 Million for Kahului Harbor

Plans, design, and construction that will provide safer and more efficient operations.

## **\$4.7 Million for the Central Maui Region Sports Complex**

Design and construction for the establishment of a Regional Park in the area of Central Maui. Includes funding for ground and site improvements as well as equipment and appurtenances.

## \$950,000 for Easter Seals, Maui

Construction for the second phase of the Maui Campus.

## \$500,000 for Maui Economic Opportunity, Inc.

Construction for various facilities.

## \$210,000 for Hale Mahaolu

Funds to operate the Hale Mahaolu Personal Care Program

### FY 2013-14 State Budget

#### **No New Taxes for the Community**

7 tax/fee proposals did not pass legislation this year.

#### **Repaying our Reserve Funds**

- \$50,000,000 to the Rainy Day Fund
- \$160,000.000 to the Hurricane Fund
- \$217,000,000 to the Health Insurance
   Fund

## Film & Digital Media Industry Development

Promotes growth in the film industry by providing tax incentives. This will potentially develop strong new economy in our community and potentially bring in millions for our State. (HB726 HD1 SD2 CD1)

#### 2013 LEGISLATIVE ACCOMPLISHMENTS

#### Bills that passed the 2013 Hawaii State Legislature

The Maui delegation proved that we were not afraid to take up tough issues this Legislative Session. Together we were able to pass many bold and overdue measures. Many community legislation included those dealing with sustainability and improving state finances. We reaffirmed our commitment to our Kupuna by appropriating funds to support health and quality of life issues. The following is a list of measures, which positively impact our community that passed through the Legislature this session.

#### **Hawaii Growth Initiative**

Supports Hawaii's business economy by providing \$6 million in funding to the Hawaii Strategic Development Corporation for the HI Growth Initiative, an investment program designed to develop, stimulate, and support high-growth entrepreneurial businesses in Hawaii and create high-paying jobs. (HB858 CD1)

#### **Financial Protection for Elderly**

Requires financial institutions to report instances of suspected financial abuse of the elderly directly to the appropriate country police department and the Department of Human Services. (SB102 SD2 HD2 CD1)

#### **Kupuna Health Programs**

Establishes and funds an
Alzheimer's Disease and Dementia
Services Coordinator, Kupuna Care
Program, Aging and Disability
Resource Centers, Senior Centers,
and Healthy Aging Partnerships.
Appropriates funds for programs and
services that support the State's
elderly population. Establishes the
Task Force on Mobility Management.
(SB106 SD1 HD1 CD1)

#### **Green Infrastructure**

Low-cost financing for solar panel installation for homes and businesses. Makes green infrastructure accessible and affordable for Hawaii's consumers. Will potentially reduce energy costs for homes over time, helps achieve Hawaii's clean energy goals through utilizing the Public Utilities Commission and the Department of Business, Economic Development, and Tourism. (SB1087 SD2 HD3 CD1)

#### **Homelessness**

Assists individuals facing or experiencing homelessness by funding various homeless and housing programs. Also provides substance abuse treatment and mental health support services. (SB515 SD2 HD1 CD1)

#### **Kaanapali Beach Nourishment**

Appropriates funds for the environmental impact statement associated with the planned beach nourishment project at Kaanapali beach on the island of Maui. (SB 1194 SD2 HD1 CD1)

#### **Memorial for War Veterans**

Directs the Office of Veterans
Services to develop a plan to
establish a memorial honoring the
veterans of the Persian Gulf War,
Operation Desert Storm, Operation
Iraqi Freedom, Operation Enduring
Freedom, Operation New Dawn,
Global War on Terrorism, Homeland
Defense, and Operation Noble Eagle,
and those who have protected our
borders by land, sea, and air. (SB551
SD2 HD1 CD1)
