## A BILL FOR AN ACT

MAKING EMERGENCY APPROPRIATIONS FOR COLLECTIVE BARGAINING COST ITEMS.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

2	SECTION 1. This Act is recommended by the governor for						
3	immediate passage in accordance with section 9 of article VII of						
4	the Hawaii State Constitution.

6.	SECTION 2. There are appropriated or authorized from the

11	salary increases and other wage related costs in the agreement						
12	negotiated with the exclusive bargaining representative of

- 16 that are not expended or encumbered by June 30, 2014, and
- 17 June 30, 2015, of the respective fiscal years, shall lapse as of
- 18 those dates.
- 19 SECTION 12. This Act shall take effect upon its approval.
