A BILL FOR AN ACT

RELATING TO CRIME.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 Section 708-872, Hawaii Revised Statutes, is 2 amended to read as follows: 3 "§708-872 Falsifying business records. (1) A person commits the offense of falsifying business records if, with 4 5 intent to defraud, the person: 6 Makes or causes a false entry in the business records (a) 7 of an enterprise; [or] Alters, erases, obliterates, deletes, removes, or 8 (b) destroys a true entry in the business records of an 9 10 enterprise; [or] Omits to make a true entry in the business records of 11 (C) 12 an enterprise in violation of a duty to do so which 13 the person knows to be imposed upon the person by law, 14 other than for the information of the government, or by the nature of the person's position; or 15 **16** (d) Prevents the making of a true entry or causes the omission thereof in the business records of an 17 18 enterprise.

- [(2) "Enterprise" means any entity of one or more persons, 1 corporate or otherwise, engaged in business, commercial, 2 3 professional, industrial, eleemosynary, or social activity. 4 (3) (2) For purposes of this section: "Business record" means any [writing or article] record kept 5 6 or maintained by an enterprise for the purpose of evidencing or reflecting its condition or activity. 7 "Electronic" means relating to technology having 8 electrical, digital, magnetic, wireless, optical, 9 electromagnetic, or similar capabilities. 10 "Enterprise" means any entity of one or more persons, 11 corporate or otherwise, engaged in business, commercial, 12 professional, industrial, eleemosynary, or social activity. 13 14 "Information" includes data, text, images, sounds, codes, computer programs, software, or databases. 15 "Record" means information that is written or printed, or **16** that is stored in an electronic or other medium and is **17** retrievable in a perceivable form. 18 [(4)] (3) Falsifying business records is a misdemeanor." 19 SECTION 2. Section 710-1000, Hawaii Revised Statutes, is 20 21 amended by adding six new definitions to be appropriately 22 inserted and to read as follows:

12		be true, in an application for any pecuniary or other	
13		benefit or in a record or report required by law to be	
14		submitted to any governmental agency;	
15	(b)	Submits or invites reliance on any [writing]	
16		statement, document, or record, in written, printed,	
17		or electronic form, which the person knows to be	
18		falsely made, completed, or altered; or	
19	(c)	Submits or invites reliance on any sample, specimen,	
20		map, boundary-mark, or other object the person knows	
21		to be false.	

- 1 (2) Unsworn falsification to authorities is a
- 2 misdemeanor."
- 3 SECTION 7. This Act does not affect rights and duties that
- 4 matured, penalties that were incurred, and proceedings that were
- 5 begun, before the effective date of this Act.
- 6 SECTION 8. Statutory material to be repealed is bracketed
- 7 and stricken. New statutory material is underscored.
- 8 SECTION 9. This Act shall take effect upon its approval.
