A BILL FOR AN ACT

RELATING TO INSURANCE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the federal Patient
 2 Protection and Affordable Care Act of 2010 (Affordable Care Act)
 3 encourages states to develop innovative approaches to insuring
- 4 their populations by authorizing states to apply for waivers
- 5 from certain requirements of the Affordable Care Act. To be
- 6 eligible, a state must demonstrate that its proposed health
- 7 insurance reforms are as comprehensive and affordable as the
- 8 federal requirements for insurance sold in its state health
- 9 insurance exchange. In addition, proposed reforms must be
- 10 budget neutral for the federal government. States that are
- 11 granted innovation waivers may receive federal assistance to
- 12 operate their reform programs in an amount that is equivalent to
- 13 the aggregate amount of tax credits and cost-sharing subsidies
- 14 that the federal government would have paid for individuals
- 15 enrolled in state health insurance exchanges.
- 16 The legislature also finds that Hawaii has a bold history
- 17 as an innovator in ensuring that its residents have access to

- 1 health care. The Hawaii Prepaid Health Care Act has ensured the
- 2 availability of employer-sponsored health insurance for workers
- 3 and their families, and the State's medicaid program has
- 4 provided access to comprehensive managed care for low-income
- 5 families. The legislature believes that, while Hawaii has taken
- 6 great steps in implementing the health insurance exchange and
- 7 other insurance reforms required by the Affordable Care Act, the
- 8 State may be able to create a more effective alternative
- 9 solution for providing affordable health coverage to
- 10 individuals.
- The purpose of this Act is to establish a state innovation
- 12 waiver task force to develop a health care reform plan that
- 13 meets requirements for obtaining a state innovation waiver.
- 14 SECTION 2. (a) There is created the state innovation
- 15 waiver task force, to be temporarily attached to the office of
- 16 the governor for administrative purposes.
- 17 (b) The task force shall consist of the following members,
- 18 or their respective designees:
- 19 (1) The healthcare transformation coordinator, who shall
- 20 serve as chair;
- 21 (2) The director of health;

2	(4)	The administrator of the MedQUEST division of the
3		department of human services;
4	(5)	The insurance commissioner;

7		information management and technology;
8	(8)	The administrator of the Hawaii employer-union health
9		benefits trust fund;
10	(9)	The executive director of the Hawaii Health Connector;
11	(10)	The executive director of the Hawaii Health

13	(11)	A representative of The Chamber of Commerce of Hawaii;

6	(c)	The task force shall:
7	(1)	Examine the feasibility of alternative approaches to
8		the health reform requirements described under Section
9		1332(a)(2) of the federal act;
10	(2)	Examine alternatives to and possible exemptions or
11		waivers from requirements relating to allowable
12		premium rate variations based upon age, as described
13		in Section 1201 of the federal act;
14	(3)	Examine the feasibility of options for providing
15		affordable insurance coverage for uninsured and
16		underinsured individuals in Hawaii through brokers and
17		professional employer organizations that include
18		innovations to the State's existing medicaid program;
19		and

1	(4)	Develop a plan for applying for a state innovation
2		waiver that meets the requirements of Section 1332 of
3		the federal act, including:
4		(A) Developing a strategy for health care reform
5		that:
6		(i) Provides coverage that is at least as
7		comprehensive as required by the federal
8		act;
9		(ii) Provides coverage and cost-sharing
10		protections that are at least as affordable
11		as under the federal act;
12		(iii) Makes health insurance coverage available to
13		as many residents of Hawaii as under the
14		federal act; and
15		(iv) Is budget neutral for the federal
16		government;
17		(B) Examining the feasibility of options for
18		providing affordable insurance coverage for
19		uninsured and underinsured individuals in Hawaii
20		that include innovations to the State's existing
21		medicaid program; and

1	(c) Ensuring compriance with all applicable public
2	notice requirements of title 31 Code of Federal
3	Regulations part 33 and title 45 Code of Federal
4	Regulations part 155, as amended.
5	(d) The task force shall prepare a draft application for a
6	state innovation waiver, to take effect for plan years beginning
7	on or after January 1, 2017.
8	(e) The members of the task force shall serve without
9	compensation but shall be reimbursed for expenses, including
10	travel expenses, necessary for the performance of their duties.
11	(f) The task force shall submit an initial interim report
12	to the legislature no later than twenty days prior to the
13	convening of the regular session of 2015. The task force shall
14	submit a second interim report to the legislature no later than
15	twenty days prior to the convening of the regular session of
16	2016. The interim reports shall include:
17	(1) Identification of opportunities for state agencies to
18	collaborate on new information technology that will
19	advance the goals of the federal act and state
20	innovation; and

1	(2)	Recommendations on the allocation of existing moneys
2		available for health reform and innovation, including
3		any proposed legislation.

- 4 (g) The task force shall submit a final report of its
- 5 findings and recommendations to the legislature, including any
- 6 proposed legislation and the draft application, no later than
- 7 twenty days prior to the convening of the regular session of
- 8 2017.
- 9 (h) The task force shall be dissolved on June 30, 2017.
- 10 (i) For the purposes of this section, "federal act" means
- 11 the Patient Protection and Affordable Care Act (Public Law 111-
- 12 148), as amended, and any regulations adopted thereunder.
- 13 SECTION 3. This Act shall take effect upon its approval.
