Dear President Kim:

Transmitted herewith are proposed changes to the FY 15 Supplemental Budget for the Department of the Attorney General (AG), Department of Health (DOH), Department of Labor and Industrial Relations (DLIR), and Department of Transportation (DOT).

Your favorable consideration is requested for the attached budget items:

### AG – Legal Services

Adds \$80,000 in special funds for the Solicitation of Funds for Charitable Purposes program to provide an on-line registration system for professional solicitators and fund raising counsels. System will also allow timelier reporting of public records requests for charitable organizations.

#### DOH – <u>Developmental Disabilities Division</u>

Adds \$2,073,049 in general funds for the Home and Community Based Services Medicaid Waiver program to provide services to Compact Free Assosication citizens with developmental disabilities, as mandated by the United States District Court ruling which requires 100% State funding.

## DLIR – Workforce Development Program (LBR 111/PA)

Adds \$1,640,000 in non-major, recurring other federal funds (Means of Financing (MOF) P) and reduces \$13,936,057 in major, recurring federal funds (MOF N) to correct a technical error based on the Federal Fund Information for States listing and projected FY 15 grant awards.

## DLIR - Workforce Development Program (LBR 111/PB)

Reduces \$22,336,395 in major, recurring federal funds (MOF N) to more accurately reflect projected FY 15 grant awards.

## DLIR - Workforce Development Council (LBR 135/IA)

Adds \$600,000 in non-major, recurring other federal funds (MOF P) based on the Federal Fund Information for States listing and projected expenditure levels. Adds \$406,216 in major, recurring federal funds (MOF N) based on projected FY 15 grant awards.

## DLIR - Hawaii Occupational Safety and Health Program (LBR 143/EA)

Adds 18.50 positions and \$2,000,000 in non-major, other recurring federal funds (MOF P) and reduces 18.50 positions and \$1,848,025 in major, recurring federal funds (MOF N) to correct a technical error based on the Federal Fund Information for States listing and projected FY 15 grant awards.

## DLIR – Hawaii Civil Rights Commission (LBR 153/RA)

Adds 0.50 permanent and 5.00 temporary positions and \$250,000 in non-major, other recurring federal funds (MOF P) and reduces 0.50 permanent and 5.00 temporary positions and \$324,087 in major, recurring federal funds (MOF N) to correct a technical error based on the Federal Fund Information for States listing and projected FY 15 grant awards.

## DLIR - Unemployment Insurance Program (LBR 171/LA)

Adds \$2,248,653 in major, recurring federal funds (MOF N) to more accurately reflect projected FY 15 grant awards.

## DLIR – Employment Security Appeals Referees' Office (LBR 871/LB)

Adds \$102,726 in major, recurring federal funds (MOF N) to more accurately reflect projected FY 15 grant awards.

## DLIR - Data Gathering, Research and Analysis (LBR 901/GA)

Adds 26.57 positions and \$950,000 in non-major, other recurring federal funds (MOF P) and reduces 26.57 positions and \$2,044,410 in major, recurring federal funds (MOF N) to correct a technical error based on the Federal Fund Information for States listing and projected FY 15 grant awards.

#### DLIR – General Administration (LBR 902/AA)

Adds 33.48 permanent and 4.54 temporary positions and \$3,500,000 in non-major, other recurring federal funds (MOF P) and reduces 33.48 permanent and 4.54 temporary positions and \$3,361,247 in major, recurring federal funds (MOF N) to correct a technical error based on the Federal Fund Information for States listing and projected FY 15 grant awards.

## DLIR - Office of Community Services (LBR 903/NA)

Adds \$200,000 in non-major, other recurring federal funds (MOF P) and reduces \$1,552,341 in major, recurring federal funds (MOF N) to correct a technical error based on the Federal Fund Information for States listing and projected FY 15 grant awards.

## DLIR - Hawaii Career (Kokua) Information Delivery System (LBR 905/GB)

Reduces 1.00 temporary position and \$30,939 in major, recurring federal funds (MOF N) to more accurately reflect position count and projected FY 15 grant awards.

## DOT - Maui Highways

Adds \$3,000,000 in highways special funds to establish and maintain conditions for a new National Pollutant Discharge Elimination System, Municipal Separate Storm Water System (MS4) permit, for Maui District. Kahului, Maui, has been identified as an urban area based on the 2010 U.S. Census and is, therefore, now subject to the MS4 permitting requirements.

#### DOT - Highways Administration

Adds \$210,000 (\$70,000 highways special funds; \$140,000 federal funds) for the Local Technical Assistance program to provide ongoing training and technology transfer to State Highways staff for workforce development, continuing education, and career advancement to better operate and maintain the State transportation system.

Adds \$274,047 in highways special funds for anticipated additional central services surcharge expenses.
