RELATING TO SIMULATED FIREARMS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 707-701, Hawaii Revised Statutes, is 1 2 amended by adding a new definition to be appropriately inserted and to read as follows: 3 ""Simulated firearm" means any object that: 4 5 (1) Substantially resembles a firearm; (2) Can reasonably be perceived to be a firearm; or 6 7 (3) Is used or brandished as a firearm." 8 SECTION 2. Section 707-716, Hawaii Revised Statutes, is 9 amended by amending subsection (1) to read as follows: 10 "(1) A person commits the offense of terroristic 11 threatening in the first degree if the person commits terroristic threatening: 12 By threatening another person on more than one 13 (a) 14 occasion for the same or a similar purpose; 15 By threats made in a common scheme against different (b) 16 persons; Against a public servant arising out of the 17 (c) 18 performance of the public servant's official duties.

1		For the purposes of this paragraph, "public servant"
2		includes but is not limited to an educational worker.
3		"Educational worker" has the same meaning as defined
4		in section 707-711;
5	(d)	Against any emergency medical services provider who is
6		engaged in the performance of duty. For purposes of
7		this paragraph, "emergency medical services provider"
8		means emergency medical services personnel, as defined
9		in section 321-222, and physicians, physician's
10		assistants, nurses, nurse practitioners, certified
11		registered nurse anesthetists, respiratory therapists,
12		laboratory technicians, radiology technicians, and
13		social workers, providing services in the emergency
14		room of a hospital;
15	(e)	With the use of a dangerous instrument[ $\div$ ] or a
16		<pre>simulated firearm; or</pre>
17	(f)	By threatening a person who:
18		(i) The defendant has been restrained from, by order
19		of any court, including an ex parte order,
20		contacting, threatening, or physically abusing
21		pursuant to chapter 586; or

1	(ii) Is being protected by a police officer ordering								
2	the defendant to leave the premises of that								
3	protected person pursuant to section 709-906(4),								
4	during the effective period of that order."								
5	SECTION 3. Section 708-800, Hawaii Revised Statutes, is								
6	amended by adding a new definition to be appropriately inserted								
7	and to read as follows:								
8	""Simulated firearm" means any object that:								
9	(1) Substantially resembles a firearm;								
10	(2) Can reasonably be perceived to be a firearm; or								
11	(3) Is used or brandished as a firearm."								
12	SECTION 4. Section 708-840, Hawaii Revised Statutes, is								
13	amended by amending subsection (a) to read as follows:								
14	"(1) A person commits the offense of robbery in the first								
15	degree if, in the course of committing theft or non-consensual								
16	taking of a motor vehicle:								
17	(a) The person attempts to kill another or intentionally								
18	or knowingly inflicts or attempts to inflict serious								
19	bodily injury upon another;								
20	(b) The person is armed with a dangerous instrument or a								
21	simulated firearm and:								

1		(i) The person uses force against the person of							
2		anyone present with intent to overcome that							
3		person's physical resistance or physical power of							
4		resistance; or							
5		(ii) The person threatens the imminent use of force							
6		against the person of anyone present with intent							
7		to compel acquiescence to the taking of or							
8		escaping with the property;							
9	(c)	The person uses force against the person of anyone							
10		present with the intent to overcome that person's							
11		physical resistance or physical power of resistance							
12		during the time of a civil defense emergency							
13		proclaimed by the governor pursuant to chapter 128,							
14		within the area covered by the civil defense emergency							
15		or during the period of disaster relief under chapter							
16		127; or							
17	(d)	The person threatens the imminent use of force against							
18		the person of anyone present with intent to compel							
19		acquiescence to the taking of or escaping with the							
20		property during the time of a civil defense emergency							
21		proclaimed by the governor pursuant to chapter 128,							
22		within the area covered by the civil defense emergency							

1	or	during	the	period	of	disaster	relief	under	chapter

2 127."

- 4 matured, penalties that were incurred, and proceedings that were
- 5 /begun before its effective date.
