## A BILL FOR AN ACT

RELATING TO THE REGENTS CANDIDATE ADVISORY COUNCIL.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that while the candidate
advisory council for the board of regents of the University of
Hawaii has nominated many outstanding appointees to the board,

4 important concerns have been raised as to the selection process.

5 Since the passage of Act 56, Session Laws of Hawaii 2007, to

6 implement the amendments to article X, section 6 of the state

7 constitution, a number of issues have arisen from the new method

8 of regent selection that hampered the work of the regents

9 candidate advisory council and led to questions regarding the

10 final selection of appointees during the senate confirmation

11 process.

The purpose of this Act is to reconstitute the form and processes of the candidate advisory council to increase the

14 appointment of qualified individuals to serve as members of the

15 board of regents and effectively lead the University of Hawaii.

16 SECTION 2. Chapter 304A, Hawaii Revised Statutes, is

17 amended by adding a new section to be appropriately designated

18 and to read as follows:

- 1 (k) Members of the candidate advisory council shall serve 2 without compensation but shall be reimbursed for expenses, 3 including travel expenses, necessary for the performance of 4 their duties." 5 SECTION 3. Section 304A-104, Hawaii Revised Statutes, is 6 amended to read as follows: 7 "\$304A-104 Regents; appointment; tenure; qualifications; 8 meetings. (a) The affairs of the university shall be under the 9 general management and control of the board of regents 10 [consisting]. The board shall consist of fifteen members who 11 shall be appointed [and] by the governor from lists of qualified 12 candidates presented to the governor by the candidate advisory 13 council, pursuant to section 304A- , and shall be confirmed by 14 the senate; provided that if the list of qualified candidates includes less than three candidates at any time during the 15 **16** nomination and confirmation process, the governor may request 17 that the candidate advisory council reopen recruitment for 18 qualified candidates. Members may be removed by the governor. 19 Except as otherwise provided by law, state officers shall be 20 eligible for appointment and membership. The term of each member shall be five years, except as 21 22 provided for the initial appointment in section 26-11; provided

- 1 that the term of the student member shall be two years. Every
- 2 member may serve beyond the expiration date of the member's term
- 3 of appointment until the member's successor has been appointed
- 4 by the governor and confirmed by the senate in accordance with
- 5 article X, section 6 of the Hawaii constitution. Members shall
- 6 serve no more than two consecutive five-year terms; provided
- 7 that the members who are initially appointed to terms of two
- 8 years or less pursuant to section 26-11(a) may be reappointed to
- 9 two ensuing five-year terms. If a member is to be appointed to
- 10 a second term of five years, the senate shall consider the
- 11 question of whether to reconfirm the member at least one hundred
- 12 twenty days prior to the conclusion of a member's first five-
- 13 year term; provided that if the senate is not in session within
- 14 one hundred twenty days prior to the conclusion of the member's
- 15 first five-year term, the member shall continue to serve until
- 16 the senate convenes for the next regular session or the next
- 17 special session for which the senate is authorized to consider
- 18 the question of reconfirmation.
- 19 (b) In determining whether to confirm the governor's
- 20 nominee to the board of regents, the senate shall consider the
- 21 combination of abilities, breadth of experiences, and
- 22 characteristics of the board of regents, as a whole, that will



- 1 best serve the diverse interests and needs of the students of
- 2 the university system and assist the university system in
- 3 achieving its strategic goals and performance indicators. The
- 4 senate shall consider whether the board reflects the diversity
- 5 of the student population, the various counties of the State,
- 6 and a broad representation of higher education-related
- 7 stakeholders.
- 8 [\(\frac{\text{(b)}}{\text{]}}\) (c) At a meeting preceding July 1 of each year, the
- 9 board of regents shall elect a chairperson and up to two vice-
- 10 chairpersons whose terms shall be from July 1 to June 30 of the
- 11 next year or thereafter until their successors are elected. The
- 12 board shall appoint a secretary, who shall not be a member of
- 13 the board. The president of the university shall act as
- 14 executive officer of the board. A majority of the board of
- 15 regents shall constitute a quorum to conduct business, and the
- 16 concurrence of a majority of all the members to which the board
- 17 of regents is entitled shall be necessary to make any action of
- 18 the board of regents valid. The board shall meet at least ten
- 19 times annually and, from time to time, may meet in each of the
- 20 counties of Hawaii, Maui, and Kauai.

- 22 candidate advisory council for the board of regents of the

(a) There is 12 established the regents candidate advisory council for the board 13 of regents of the University of Hawaii to present to the 14 governor pools of qualified candidates from which the members of 15 the board of regents shall be nominated and, by and with the 16 consent of the senate, appointed by the governor. The regents 17 candidate advisory council shall establish the criteria for 18 qualifying, screening, and presenting to the governor candidates 19 for membership on the board of regents. Appointees shall be individuals who are widely viewed 4 5 as having placed the broad public interest ahead of special 6 interests, having achieved a high level of prominence in their 7 respective professions, and being respected members of the 8 community. (q) Members of the regents candidate advisory council 9 10 shall serve four-year terms. 11 (h) If a vacancy occurs, a successor shall be appointed in 12 the same manner and subject to the same qualifications as the person's predecessor. The person appointed to fill a vacancy 13 14 shall serve for the remainder of the term of the person's 15 predecessor. 16 (i) The regents candidate advisory council shall operate in a wholly nonpartisan manner. No individual, while a member 17 18 of the regents candidate advisory council, shall run for or hold 19 any elected office under the United States or the State or any 20 of its political subdivisions. 21 (j) The members of the regents candidate advisory council 22 shall choose a chairperson from among themselves. A majority of



all the members to which the regents candidate advisory council 1 is entitled shall constitute a quorum to conduct business. The 2 concurrence of a majority of all the members to which the 3 regents candidate advisory council is entitled shall be 4 5 necessary to make any action of the regents candidate advisory 6 council valid. The regents candidate advisory council shall meet annually and at other times as necessary. The regents 7 candidate advisory council shall be exempt from part I of 8 9 chapter 92. 10 (k) Members of the regents candidate-advisory council 11 shall serve without compensation but shall be reimbursed for expenses, including travel, board, and lodging expenses, 12 necessary for the performance of their duties. 13 14 (1) Notwithstanding chapter 92F or any other law to the contrary, all information required by the regents candidate 15 advisory council shall be confidential, including without **16** limitation, all council information obtained, reviewed, or 17 considered before and after council decisionmaking. 18 19 Confidential regents candidate advisory council information 20 shall include documents, data, or other information that are not of public record, including without limitation, personal 21 22 financial information; the names of applicants; applications and HB1071 SD2 LRB 13-2513.doc



1 the personal, financial, and other information contained therein 2 submitted by the applicants to the regents candidate advisory council; interviews; schedules; reports; studies; background 3 4 checks; credit reports; surveys and reports prepared for or on 5 the regents candidate advisory council's behalf; the results of any evaluations or assessments conducted by the regents 6 7 candidate advisory council; the substance and details of any 8 discussions with regents candidate advisory council members; and 9 the substance and details of discussions and deliberations of 10 the regents candidate advisory council and any of its committees 11 during meetings."] 12 SECTION 5. The members of the candidate advisory council 13 for the board of regents of the University of Hawaii who are 14 serving on the effective date of this Act shall serve until the council is reconstituted by the appointment of the seven members 15 to the council pursuant to this Act, at which time the members 16 17 of the regents candidate advisory council who are serving on the 18 effective date of this Act shall be discharged from office and 19 the members appointed by the president of the senate, speaker of 20 the house of representatives, and governor pursuant to this Act 21 shall begin their service.
