A BILL FOR AN ACT

RELATING TO HUMAN TRAFFICKING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the United States is
- 2 not exempt from the crisis of human trafficking that is evident
- 3 in other countries. Cases of human trafficking have been
- 4 reported in all fifty states, Washington D.C., and some of the
- 5 United States territories.
- 6 The legislature further finds that human trafficking is not
- 7 limited to adults; trafficking can involve school-age children,
- 8 particularly those not living with their parents, who are
- 9 vulnerable to coerced labor exploitation, domestic servitude, or
- 10 commercial sexual exploitation.
- 11 The purpose of this Act, therefore, is to combat human
- 12 trafficking by raising consciousness in Hawaii's public schools
- 13 so that teachers, counselors, other department of education
- 14 employees, parents, and other students can identify victims and
- 15 report suspected incidences of human trafficking.
- 16 SECTION 2. Section 302A-802, Hawaii Revised Statutes, is
- 17 amended to read as follows:

- 1 "§302A-802 Licensing standards; policies. (a) The board
- 2 shall establish licensing standards that govern teacher
- 3 licensing in Hawaii. Licensing standards established by the
- 4 board shall be adopted as rules under chapter 91 unless
- 5 otherwise specified in this subpart.
- 6 (b) The board, beginning January 1, 2014, shall include in
- 7 its licensing standards a minimum of two hours of instruction
- 8 designed to combat human trafficking by raising awareness about
- 9 human trafficking, including how to identify victims of human
- 10 trafficking and strategies for the prevention of human
- 11 trafficking of children. The board may include this instruction
- 12 as a requirement for the approval of teacher education programs
- 13 pursuant to section 302A-805.5.
- 14 [\(\frac{(b)}{c}\)] (c) In the development of its standards, the board
- 15 shall consider the existing teacher applicant pool that is
- 16 available in the State and the level of the qualification of
- 17 these applicants, as well as the nature and availability of
- 18 existing preservice higher education teacher training programs.
- 19 [(e)] (d) The board shall adopt policies, exempt from
- 20 chapters 91 and 92, to initiate the following:
- 21 (1) Develop criteria allowing more individuals with trade
- or industry experience to teach in vocational,

1		technical, and career pathway programs, and criteria
2		for the issuance of permits allowing qualified
3		individuals to teach when recommended by the
4		superintendent. The department shall be responsible
5		for the review and acceptance of the relevant
6		licenses, certificates, or other qualifications
7		related to an individual's vocational, technical, or
8		career pathway education-related experience that the
9		department deems necessary for a permit. The
10		department shall have the authority to waive the
11		requirement of a bachelor's degree to teach in a
12		vocation, technical, or career pathway education
13		program;
14	(2)	Develop a plan to accept teachers from any state as
15		long as they have completed state-approved teacher
16		education programs and pass relevant Hawaii teacher
17		examinations or their equivalent;
18	(3)	Clarify the requirements, on a state-by-state basis,
19		for out-of-state licensed teachers to obtain a license
20		in Hawaii;
21	(4)	Develop a plan to facilitate licensing for those who
22		intend to teach in Hawaii immersion programs, the

20	full-time	teacher in a public school without first having

22	licenses	issued by the board shall be valid only for the fields

- 3 license if the individual continues to:
- 4 (1) Satisfy the board's licensing standards and submits

- 8 performance standards established by the board;
- 9 (2) Show evidence of successful teaching in the previous
- 10 five years through verification by a supervisor, in a
- form specified by the board;
- 12 (3) Meet the professional fitness requirements established
- by the board;
- 14 (4) Satisfy the board's requirements for renewal of
- 15 licenses; and
- 16 (5) Pay all applicable license fees in a timely manner.
- 17 As an additional condition precedent to the renewal of a license
- 18 under this section, beginning January 1, 2014, the individual
- 19 shall have completed an additional two hours of instruction
- 20 designed to combat human trafficking, pursuant to the licensing
- 21 requirement in section 302A-802.

- 3 (b) The department of human services, in collaboration
- 4 with experts in the field of human trafficking, shall provide to
- 5 the department of education:
- 6 (1) Resource information on human trafficking, including
- 7 strategies for the prevention of human trafficking of
- 8 children, to be distributed to school principals,
- 9 teachers, and counselors; and
- 10 (2) Materials for distribution that describe state and
- 11 national resources to which students, parents,
- 12 counselors, and school personnel can refer for
- information on human trafficking, including strategies
- 14 that will assist in the prevention of child human
- trafficking.
- 16 SECTION 5. (a) The department of education, in
- 17 collaboration with the department of human services and experts
- 18 in the field of human trafficking, shall develop, as part of the
- 19 department of education's health curriculum, content on human
- 20 trafficking. Such content shall include methods used to lure
- 21 children into trafficking, identification of trafficking
- 22 victims, the treatment of victims of human trafficking, by

- 1 traffickers, strategies that assist in the prevention of child
- 2 human trafficking, and resource information on human
- 3 trafficking.
- 4 (b) The curriculum required by subsection (a) shall be
- 5 included in the department of education's health education
- 6 curriculum no later than the 2013-2014 school year.
- 7 SECTION 6. Statutory material to be repealed is bracketed
- 8 and stricken. New statutory material is underscored.
- 9 SECTION 7. This Act shall take effect upon its approval.
