A BILL FOR AN ACT

RELATING TO UNIFORM COMMERCIAL CODE ARTICLE 4A.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that amendments to the 2 federal Electronic Fund Transfer Act, which go into effect in 3 2013, do not address the rights and responsibilities of the parties involved in some consumer international wire transfers, 4 5 also known as "remittance transfers". Amendments to article 4A 6 of the Uniform Commercial Code are therefore needed to clarify 7 when the Uniform Commercial Code will govern those transactions. 8 The purpose of this Act is to clarify the relationship 9 between the Uniform Commercial Code article 4A and the federal 10 Electronic Fund Transfer Act. SECTION 2. Section 490:4A-108, Hawaii Revised Statutes, is 11 12 amended to read as follows: 13 "§490:4A-108 [Exclusion of consumer transactions governed 14 by federal law.] Relationship to Electronic Fund Transfer Act. 15 [This] (a) Except as provided in subsection (b), this article 16 does not apply to a funds transfer any part of which is governed

by the Electronic Fund Transfer Act of 1978 (Title XX, Public
