RELATING TO HUMAN SERVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that current State
2	welfare policy often penalizes welfare recipients who seek job
3	promotions or higher paying career opportunities. This
4	increased income often causes welfare recipients to lose their
5	beneficiary status, thus perpetuating financial hardship. The
6	legislature further finds there is a need to revise the welfare
7	payment system to allow recipients to advance in their careers
8	without necessarily losing their beneficiary status.
9	The purpose of this Act is to:
10	(1) Establish a task force that shall develop a
11	restructured welfare payment system; and
12	(2) Re-establish the exit and retention bonus program to
13	encourage welfare recipients to transition back into
14	the workforce.
15	SECTION 2. (a) Beginning no later than January 1, 2014,
16	the department of human services, including the Financial
17	Assistance Advisory Council, shall convene a task force to

1 incentivize qualifying welfare recipients to advance in their
2 careers while retaining their beneficiary status. The task
3 force shall:

4 (1) Examine the current welfare payment structure; 5 (2) Revise the welfare payment structure to incentivize 6 qualifying recipients to advance in their careers or 7 seek high paying jobs without necessarily causing 8 recipients to lose their welfare beneficiary status; 9 (3) Create a sliding scale payment system to incrementally 10 reduce welfare payments to recipients as they advance 11 in their careers or obtain higher paying jobs; and 12 (4) Explore other possible methods to incentivize welfare 13 recipients to seek financial self-sufficiency. 14 The task force shall report to the legislature no (b) 15 later than twenty days prior to the convening of the 2015 16 regular session on its findings and recommendations, including any recommendations for an implementation plan or legislation. 17

18 SECTION 3. Beginning no later than January 1, 2014, the 19 department of human services shall re-establish the exit and 20 retention bonus program. The program shall:

(1) Be available to recipients who voluntarily terminate
 their welfare benefits within a twenty-four month

1	period and remain out of the welfare system;
2	(2) Provide bonuses available after three, six, twelve, and
3	twenty-four months, with bonus amounts increasing for
4	more hours of employment; and
5	(3) Provide a maximum bonus amount over a period of twenty-
6	four months.
7	SECTION 4. There is appropriated out of the general
8	revenues of the State of Hawaii the sum of \$ or
9	so much thereof as may be necessary for fiscal year 2013-2014 to
10	re-establish the exit and retention bonus program.
11	The sum appropriated shall be expended by the department of
12	human services for the purposes of this Act.
13	SECTION 5. This Act shall take effect upon its approval.
