### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

15		cases in which the covered offense is chargeable as a
16		felony offense under state law;

18		to the extent of an interest of an owner, by reason of
19		any act or omission established by that owner to have
20		been committed or omitted without the knowledge and
21		consent of that owner;

2		carrier in the transaction of a business as a common
3		carrier is subject to forfeiture under this section

7	[ <del>-(d)-</del> ]	(c) No conveyance is subject to forfeiture under this
8		section by reason of any act or omission established
9		by the owner thereof to have been committed or omitted

11	[ <del>-(e)</del> ]	(d) A forfeiture of a conveyance encumbered by a bona
12		fide security interest is subject to the interest of
13		the secured party if the secured party neither had
14	,	knowledge of nor consented to the act or omission."
15	SECT	ION 3. This Act does not affect rights and duties that
16	matured,	penalties that were incurred, and proceedings that were
17	begun bef	ore its effective date.
