## A BILL FOR AN ACT

RELATING TO FUNDS TRANSFERS.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the Dodd-Frank Wall 2 Street Reform and Consumer Protection Act amendments to the federal Electronic Fund Transfer Act, which go into effect in 3 4 2013, do not address the rights and responsibilities of the 5 parties involved in certain consumer international wire transfers, also known as "remittance transfers." Amendments to 6 article 4A of the Uniform Commercial Code are therefore needed 7 8 to clarify when the Uniform Commercial Code will govern those 9 transactions. The purpose of this Act is to clarify the relationship between article 4A of the Uniform Commercial Code 10 11 and the federal Electronic Fund Transfer Act. SECTION 2. Section 490:4A-108, Hawaii Revised Statutes, is 12 13 amended to read as follows: 14 "\$490:4A-108 [Exclusion of consumer transactions governed 15 by federal law. Relationship to Electronic Fund Transfer Act of 16 1978. [This] (a) Except as provided in subsection (b), this

- 16 SECTION 4. This Act shall take effect on July 1, 2030.
