

A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE BENEFIT OF THE FIFTIETH REPRESENTATIVE DISTRICT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The director of finance is authorized to issue						
2	general obligation bonds in the sum of \$12,772,000 or so much						
3	thereof as may be necessary, and the same sum or so much thereof						
4	as may be necessary is appropriated for fiscal year 2013-2014						
5	for the purpose of capital improvement projects for the fiftieth						
6	representative district, as follows:
