## A BILL FOR AN ACT

RELATING TO SERVICE BY PUBLICATION.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the manner by which
- 2 a summons is published within this State for civil actions
- 3 should be consistent with how notices are published as required
- 4 by other provisions of the Hawaii Revised Statutes.
- 5 The purpose of this Act is to specify the manner by which a
- 6 summons is published for civil actions within this State.
- 7 SECTION 2. Chapter 634, Hawaii Revised Statutes, is
- 8 amended by adding a new section to be appropriately designated
- 9 and to read as follows:
- 10 "§634- Service by publication. (a) When service of a
- 11 summons is required by law, court rule, or court order, and
- 12 service of the summons on a defendant by personal delivery or by
- 13 certified, registered, or express mail is not successful despite
- 14 a reasonable attempt, and if the facts shall appear by
- 15 affidavit, declaration, or otherwise to the satisfaction of the
- 16 court, the court may order that service of the summons be made
- 17 by publication:

1	(1)	In a newspaper published in the State and having a	
2		general circulation in the circuit in which the action	
3		has been filed. The summons shall be published once	
4		each week for three consecutive weeks, which shall	
5		constitute three publications. The third publication	
6		shall be at least twenty-one days before the return	
7		date stated in the summons; or	
8	(2)	On a state website at the discretion of the agency	
9		that maintains the website, in a manner and for such	
10		time as the court may order, but at least twenty-one	
11		days before the return date stated in the summons;	
12		provided that the summons shall also be published at	
13		least once in a newspaper described in paragraph (1)	
14		at least twenty-one days before the return date.	
15	(b)	As used in this section, "general circulation" refers	
16	6 to a newspaper that:		
17	(1)	Contains news of a general nature; and	
18	(2)	Is distributed within the circuit in which the action	
19		has been filed:	
20		(A) At least weekly;	

1	<u>(B)</u> <u>1</u>	For a minimum of one year unless interrupted by		
2	<u>\$</u>	strike, natural disaster, or act of war or		
3	<u> 1</u>	cerror; and		
4	(C) <u>-</u>	To a minimum of three per cent of the residents		
5	<u> </u>	of the circuit, as determined by the last		
6	<u> </u>	decennial United States census and as verified by		
7	<u>.</u>	an independent audit."		
8	SECTION 3. Section 634-36, Hawaii Revised Statutes, is			
9	amended to read as follows:			
10	"§634-36 I	Manner of service under sections 634-33 to 35.		
11	When service of summons is provided for by section 634-33, 634-			
12	34, or 634-35, service shall be made by service upon the			
13	defendant personally by any person authorized to serve process			
14	in the place in which the defendant may be found or appointed by			
15	the court for the purpose, or sent by certified, registered, or			
16	express mail, postage prepaid, with return receipt requested, by			
17	the plaintiff or the plaintiff's attorney to the defendant. The			
18	plaintiff or the plaintiff's attorney shall file the return of			
19	the serving offi	cer or an affidavit showing that the copy of		
20	summons and complaint were served as aforesaid or sent by			
21	certified, regis	stered, or express mail as aforesaid, and in the		
22	latter case the return receipt signed by the defendant shall be

- 1 filed with the affidavit. The service shall be complete upon
- 2 delivery of the required papers to the defendant outside the
- 3 State, personally or by mail as provided.
- 4 [If the defendant cannot be found to serve or mail the
- 5 summons and the facts shall appear by affidavit or otherwise to
- 6 the satisfaction of the court, it may order that service be made
- 7 by publication of summons in at least one newspaper published in
- 8 the State and having a general circulation in the circuit in
- 9 which the action has been instituted, in such manner and for
- 10 such time as the court may order, but not less than once each
- 11 week in four successive weeks, the last publication to be not
- 12 less than twenty one days prior to the return date stated
- 13 therein unless a different time is prescribed by order of the
- 14 court.]"
- 15 SECTION 4. Statutory material to be repealed is bracketed
- 16 and stricken. New statutory material is underscored.
- 17 SECTION 5. This Act shall take effect upon its approval.

Civil Actions; Service by Publication; Newspapers; Websites

## Description:

Specifies the method of service of process for all civil cases under chapter 634, Hawaii Revised Statutes, when personal service is unsuccessful, to include publication in a newspaper of general circulation three times or publication in a newspaper of general circulation once followed by publication on a state website. (HB1415 HD1)
