# A BILL FOR AN ACT

RELATING TO REPORTING DEATHS TO STATE AGENCIES.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. The legislature finds that some governmental 1 agencies within the State that keep official lists of persons, 2 in the ordinary course of the agency's activities, need to know 3 when members on their lists have died so that they can, for 4 example, discontinue providing benefits. Although section 338-5 18(g), Hawaii Revised Statutes, allows the department of health 6 to verify information contained in vital statistics records by 7 employing a process that matches its vital statistics 8 information with information provided by agencies, that process 9 cannot be used by state agencies whose lists are confidential 10 under federal law. 11 The legislature also finds that it is unlawful for the

Chapter 338, Hawaii Revised Statutes, is 3 amended by adding a new section to be appropriately designated 4 and to read as follows: 5 "§338- Deaths reported to state agencies. (a) The 6 department of health, within six weeks after the end of each 7 quarter or other agreed upon period, shall deliver to a state 8 agency a list of the names of all persons whose deaths have been 9 recorded by the department during that period; provided that 10 this section shall only apply to a state agency that: 11 Maintains official lists of persons in the ordinary 12 (1)course of the agency's activities and is prohibited by 13 federal law from sharing information from the lists; 14 and 15 Has requested the information from the department 16 (2) pursuant to a written agreement. 17 The department shall determine the form and format of providing 18 the information to the agency. 19 (b) In response to an agency's first request pursuant to 20 subsection (a), the department may provide a list of the persons 21 whose deaths were recorded by the department during an agreed 22

- 1 upon period in the past. The list shall set forth the full name
- 2 of the decedent and the dates of the decedent's birth and death,
- 3 if known. The department may charge a reasonable fee to cover
- 4 its cost of providing the list. If a state agency requires
- 5 further information, the department may provide a certified copy
- 6 of the death certificate to that state agency, subject to the
- 7 requirements of section 338-14.5.
- 8 (c) Any state agency that obtains, pursuant to this
- 9 section, a list of the names of persons whose deaths have been
- 10 recorded by the department shall use the list only for the
- 11 purposes for which it was obtained and shall not further
- 12 disclose any information on the list."
- 13 SECTION 3. New statutory material is underscored.
- 14 SECTION 4. This Act shall take effect on July 1, 2050.
