A BILL FOR AN ACT

RELATING TO HAWAIIAN MUSIC AND DANCE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the history of 2 Hawaiian music and dance demonstrates a proud statement of cultural identity, and that a compilation of the collective 3 · 4 works and memorabilia of exceptional musicians and dancers who 5 are highly regarded in their respective fields of endeavor.will 6 act to preserve and perpetuate the Hawaiian culture, and promote 7 an appreciation for these art forms. The legislature finds that the establishment of a museum of 8 9 music, dance, and cultural arts may be facilitated by the 10 creation of an entity to supervise and direct the development of such a museum. Such an endeavor is best accomplished by 11 12 creating a synergy of individuals and specialists with the 13 experience and knowledge in design, Hawaiian cultural practices, 14 commercial enterprise, and museum conservation that can result 15 in the development of a museum of music, dance, and cultural 16 arts.

- 1 The purpose of this Act is to establish a museum of music,
- 2 dance, and cultural arts design committee to prepare

- 4 (1) Includes exhibit spaces, facilities for demonstrations
- 5 and performances, and accessory uses such as a gift

- 7 (2) Is experiential in design, encouraging the interaction
- 9 (3) Includes education in its mission; and
- 10 (4) Is financially viable and operated by a nonprofit
- 11 organization.
- 12 SECTION 2. Chapter 9, Hawaii Revised Statutes, is amended
- 13 by adding a new part to be appropriately designated and to read
- 14 as follows:
- 15 "PART . MUSEUM OF MUSIC, DANCE, AND CULTURAL ARTS
- 16 §9- Definitions. As used in this part, the following
- 17 words and terms shall have the following meanings unless the
- 18 context indicates a different meaning or intent:
- 19 "Committee" means the museum of music, dance, and cultural
- 20 arts design committee.
- 21 "Dance" or "Hawaiian dance" includes hula kahiko (ancient
- 22 or traditional hula), hula 'auana (modern hula), hula noho

- 1 (sitting hula), hula pahu (hula with drums), hula 'uli'uli (hula
- 2 with gourds), and hula kuolo (sitting chant dance).
- 3 "Developer" means any person, partnership, cooperative,
- 4 firm, nonprofit or for-profit corporation, or public agency
- 5 possessing the competence, expertise, experience, and resources,
- 6 including financial, personal, and tangible resources, required
- 7 to effectuate, directly or through other developers, the
- 8 development, planning, design, and construction of a museum of
- 9 music, dance, and cultural arts.
- 10 "Museum" means the museum of music, dance, and cultural
- 11 arts.
- "Music" or "Hawaiian music" includes oli (chants) of many
- 13 forms, steel guitar, kiho'alu (slack key), 'ukulele, orchestral
- 14 forms, the repertoire associated with the Royal Hawaiian Band,
- 15 big band swing style, himeni (choral singing) with and without
- 16 instrument accompaniment, leo ki'eki'e (falsetto singing), leo
- 17 ha'i, and ensemble (duets, trios, quartets, quintets, and other
- 18 harmonic combinations) singing styles.
- 19 §9- Museum of music, dance, and cultural arts design
- 20 committee; established. (a) There is established the museum of
- 21 music, dance, and cultural arts design committee consisting of

- 1 eleven members, which shall be placed within the state
- 2 foundation on culture and the arts for administrative purposes.
- 3 (b) Nine public members shall be appointed by the governor
- 4 as provided in section 26-34. The members shall be selected on
- 5 the basis of their knowledge, interest, and proven expertise in
- 6 one or more of the following fields: finance, architecture,
- 7 Hawaiian dance, Hawaiian music, Hawaiian culture, corporate
- 8 management, marketing, economics, and the visitor industry, and
- 9 shall represent all islands.
- 10 The chief executive officer of the office of Hawaiian
- 11 affairs or the chief executive officer's designee shall serve as
- 12 a member of the committee.
- The executive director of the state foundation on culture
- 14 and the arts shall be the chairperson of the committee.
- 15 §9- Purpose; powers. (a) The committee shall invite
- 16 developers to prepare plans, specifications, and designs for the
- 17 construction of the museum, and shall review for approval the
- 18 proposed museum development plans submitted by developers. The
- 19 committee shall supervise all development of the museum pursuant
- 20 to the development plan approved by the committee.
- 21 (b) The committee may establish a nonprofit group or
- 22 select a nonprofit group with the demonstrated qualifications to

- 1 manage and operate the museum, its concessions, or other for-
- 2 profit business enterprises in a manner that is self-
- 3 sustaining."
- 4 SECTION 3. There is appropriated out of the general
- 5 revenues of the State of Hawaii the sum of \$ or so
- 6 much thereof as may be necessary for fiscal year 2013-2014 and
- 7 the same sum or so much thereof as may be necessary for fiscal
- 8 year 2014-2015 to finance the design of a museum of music,
- 9 dance, and cultural arts; provided that no funds shall be
- 10 expended except in the following ratio:
- 11 (1) Fifty per cent state funds;
- 12 (2) Thirty per cent federal funds; and
- 13 (3) Twenty per cent private funds.
- 14 The sums appropriated shall be expended by the state
- 15 foundation on culture and the arts for the purposes of this Act.
- 16 SECTION 4. This Act shall take effect on July 1, 2013.
