### A BILL FOR AN ACT

RELATING TO SCHOOL SAFETY.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that schools should be
- 2 places of safety and security for children of all ages.
- 3 However, recent events, including the tragic December 2012
- 4 shooting at Sandy Hook Elementary School in Newtown,
- 5 Connecticut, highlighted the need to re-evaluate safety
- 6 procedures currently in place. Although the department of
- 7 education has safety measures in place, the legislature finds
- 8 that most of the department's classroom doors can only lock from
- 9 the outside, and not the inside.
- 10 The purpose of this Act is to enhance school safety by
- 11 requiring the department of education to install and maintain
- 12 classroom doors that can be locked and unlocked in certain
- 13 emergency situations.
- 14 SECTION 2. The Hawaii Revised Statutes, is amended by
- 15 adding a new section to be appropriately designated and to read
- 16 as follows:
- 17 "S School doors. (a) Notwithstanding any law
- 18 to the contrary, before July 1, 2015, all classroom doors of

a principal, nor a principal's designee shall be liable in any 1 2 civil action for injuries suffered as a result of a 3 determination made to: 4 (1) Issue relevant departmental guidelines regarding the 5 locking of classroom doors installed pursuant to 6 subsection (a); or 7 Lock or unlock a school building's classroom door installed pursuant to subsection (a). 8 SECTION 3. New statutory material is underscored. 9 10 SECTION 4. If any provision of this Act, or the application thereof to any person or circumstance, is held 11 invalid, the invalidity does not affect other provisions or 12 applications of the Act that can be given effect without the 13 invalid provision or application, and to this end the provisions 14 15 of this Act are severable. 16 SECTION 5. This Act does not affect rights and duties that 17 matured, penalties that were incurred, and proceedings that were 18 begun before its effective date.
