## A BILL FOR AN ACT

RELATING TO THE CONDITION OF LAND.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 663, Hawaii Revised Statutes, is
- 2 amended by adding a new section to be appropriately designated
- 3 and to read as follows:
- 4 "§663- Landowner duty to inspect; rockslides; hazards.
- 5 (a) A land occupier or landowner shall have a continuing duty
- 6 to inspect, or cause to be inspected, the land owned by the
- 7 landowner or occupied by the land occupier, as applicable, for
- 8 risk of rockslide or landslide or the presence of a natural or
- 9 man-made hazard; provided that the inspection shall be made at a
- 10 frequency and at intervals appropriate to the measure of the
- 11 risk, as is reasonable under the circumstances.
- 12 (b) A land occupier or landowner, as applicable under
- 13 subsection (a), shall keep written records of each inspection;
- 14 provided that the written records shall be admissible as
- 15 evidence in any court proceeding relating to any claim of
- 16 liability related to a rockslide, landslide, or the presence of
- 17 a natural or man-made hazard.

- 1 (c) This section shall not be deemed to preclude a county
- 2 from adopting ordinances not less stringent than contained in
- 3 this section.
- 4 (d) As used in this section:
- 5 "Land occupier" means a person who occupies, resides on, or
- 6 utilizes land or real estate of a landowner pursuant to a
- 7 written lease agreement.
- 8 "Landowner" means the possessor of a fee simple absolute
- 9 title in land or real estate and includes the State and its
- 10 political subdivisions in their capacities as owners of public
- 11 lands.
- 12 "Landslide" means the rapid downward movement of a mass or
- 13 rock, earth, or artificial fill on a slope.
- 14 "Man-made hazard" means a condition of the land created by
- 15 an element of human intent, negligence, or error that may cause
- 16 a rockslide, landslide, or other disaster.
- 17 "Natural hazard" means biological, geological,
- 18 hydrological, or seismic conditions that may cause a rockslide,
- 19 landslide, or other disaster, including a hazard potential as
- **20** defined in section 179D-3.
- "Reasonable under the circumstances" means an effort made
- 22 under reasonably foreseeable circumstances that would prevent a

9	(2)	The rock mass that has reached its current position
10		through erosion."
11	SECTION 2. This Act does not affect rights and duties that	
12	matured, penalties that were incurred, and proceedings that were	
13	begun, before its effective date.

15	SECTION 4. This Act shall take effect upon its approval.
