

## A BILL FOR AN ACT

RELATING TO PUBLIC SAFETY.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. Chapter 353, Hawaii Revised Statutes, is
2	amended b	y adding a new section to be appropriately designated
3	and to re	ad as follows:
4	" <u>§</u> 35	3- Department of public safety oversight committee.
5	(a) Ther	e is established the department of public safety
6	oversight	committee to:
7	(1)	Ensure transparency in the operations of the
8		<pre>department;</pre>
9	(2)	Analyze the effectiveness of the department's
10		governance, management of staff, operation of prisons,
11		and administration of its programs and services;
12	(3)	Evaluate the department's rehabilitation and
13		reintegration programs;
14	(4)	Evaluate the department's progress with regard to
15		justice reinvestment and the return of Hawaii
16		prisoners from mainland facilities; and
17	(5)	Review any other issues impacting the department.

1	(b)	The committee shall conduct annual site visits and
2	have acce	ss to all areas in correctional facilities, within the
3	constrain	ts of safety and security.
4 .	(c)	The committee shall be composed of:
5	(1)	Members of the standing committees of both houses of
6		the legislature whose purview is to oversee the
7		department;
8	(2)	The director of labor and industrial relations or the
9		director's designee;
. 10	(3)	The chairperson of the board of land and natural
11		resources or the chairperson's designee;
12	(4)	The director of human services or the director's
13		designee; and
14	<u>(5)</u>	The chairperson of the Hawaiian Homes Commission or
15		the chairperson's designee.
16	<u>(d)</u>	The committee shall be jointly chaired by the
17	legislati	ve standing committees' respective chairs.
18	<u>(e)</u>	The members of the committee shall serve without
19	compensat	ion, but may be reimbursed for expenses, including
20	travel ex	penses that are necessary for the performance of their
21	duties.
