13		need to be filed by a candidate who is
14		unsuccessful in a primary, special, or
15		nonpartisan election, or a candidate who is
16		elected to office in the primary, initial
17		special, or initial nonpartisan election.

The preliminary report filed by the date required 1 2 under subparagraph (A) shall be current through 3 June 30, and all other preliminary reports shall be 4 current through the fifth calendar day before the 5 filing deadline of those other preliminary reports. The filing date for the final primary report is twenty 6 (2)7 calendar days after a primary, initial special, or 8 initial nonpartisan election. The report shall be 9 current through the day of the applicable election. The filing date for the final election period report 10 (3) 11 is thirty calendar days after a general, subsequent, subsequent special, or subsequent nonpartisan 12 election. The report shall be current through the day 13 14 of the applicable election. The final election period report shall be filed by a candidate who is 15 unsuccessful in a primary, initial special, or initial 16 17 nonpartisan election or a candidate who is elected to office in the primary, initial special, or initial 18 19 nonpartisan election.  $\mathbf{20}$ (4) The filing dates for supplemental reports are:
