

A BILL FOR AN ACT

RELATING TO HEALTH PLANNING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the World Health
- 2 Organization, the United States Department of Health and Human
- 3 Services's Healthy People 2020, and the Centers for Disease
- 4 Control and Prevention all recognize social determinants of
- 5 health as the single most important factor in individual and
- 6 population health outcomes, more so than genetic disposition or
- 7 medical care. The legislature further finds that the Hawai'i
- 8 State Planning Act does not explicitly recognize social
- 9 determinants of health as an important component of health
- 10 planning.
- 11 The legislature also notes that the October 2013 report,
- 12 "Assessment and Priorities for Health & Well-Being in Native
- 13 Hawaiians & Other Pacific Peoples", by the John A. Burns School
- 14 of Medicine, identifies a number of social and other
- 15 determinants of health for Native Hawaiians, other Pacific
- 16 Islanders, and Filipinos, who as a collective continue to have
- 17 disparate health outcomes compared to the rest of the state

- 1 disparities through a social determinants of health approach may
- 2 directly and indirectly improve health outcomes and the quality
- 3 of life for Native Hawaiians, other Pacific Islanders, and all
- 4 residents of the State.
- 5 The purpose of this Act is to update the Hawai'i State
- 6 Planning Act's objectives for health to include a commitment to
- 7 eliminating health disparities by explicitly addressing social
- 8 determinants of health in order to reflect the latest medical
- 9 findings relating to the health needs of Native Hawaiians, other
- 10 Pacific Islanders, and Filipinos.
- 11 SECTION 2. Section 226-20, Hawai'i Revised Statutes, is
- 12 amended to read as follows:
- 13 "\$226-20 Objectives and policies for socio-cultural
- 14 advancement--health. (a) Planning for the State's socio-
- 15 cultural advancement with regard to health shall be directed
- 16 towards achievement of the following objectives:
- 17 (1) Fulfillment of basic individual health needs of the
- general public[-];
- (2) Maintenance of sanitary and environmentally healthful
- conditions in [Hawaii's] Hawai'i's communities[-]; and
- 21 (3) Elimination of health disparities by identifying and
- 22 addressing social determinants of health.

3	(1)	Provide adequate and accessible services and
4		facilities for prevention and treatment of physical
5		and mental health problems, including substance
6		abuse[-];
7	(2)	Encourage improved cooperation among public and
8		private sectors in the provision of health care to
9		accommodate the total health needs of individuals
10		throughout the State[-];
11	(3)	Encourage public and private efforts to develop and
12		promote statewide and local strategies to reduce
13		health care and related insurance costs[-];
14	(4)	Foster an awareness of the need for personal health
15		maintenance and preventive health care through
16		education and other measures[+];
17	(5)	Provide programs, services, and activities that ensure
18		environmentally healthful and sanitary conditions $[-]$:
19	(6)	Improve the State's capabilities in preventing
20		contamination by pesticides and other potentially
21		hazardous substances through increased coordination,
22		education, monitoring, and enforcement[+]; and

1	(7) Prioritize programs, services, interventions, and
2	activities that address identified social determinants
3	of health to reduce health disparities of Native
4	Hawaiians, other Pacific Islanders, and Filipinos."

6	and stricken. New statutory material is underscored.
7	SECTION 4. This Act shall take effect upon its approval.
