
A BILL FOR AN ACT

RELATING TO THE JUDICIARY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. This Act shall be known and may be cited as the
2 Judiciary Supplemental Appropriations Act of 2014.

3 SECTION 2. Act 133, Session Laws of Hawaii 2013, is amended by
4 amending part II to read as follows:

5 **"PART II. PROGRAM APPROPRIATIONS**

6 SECTION 3. The following sums, or so much thereof as may be
7 sufficient to accomplish the purposes and programs designated herein,
8 are appropriated or authorized from the sources of funding specified
9 to the judiciary for the fiscal biennium beginning July 1, 2013, and
10 ending June 30, 2015. The total expenditures and the number of
11 permanent positions established in each fiscal year of the fiscal
12 biennium shall not exceed the sums and the position ceilings
13 indicated for each year, except as provided in this Act.

14 "PART IV. CAPITAL IMPROVEMENT PROJECTS

15 SECTION 7. The sum of [~~\$14,825,000~~] \$104,015,000 appropriated
 16 or authorized in part II of this Act for capital improvement projects
 17 shall be expended by the judiciary for the projects listed below;
 18 provided that several related or similar projects may be combined
 19 into a single project, if a combination is advantageous or convenient
 20 for implementation; and provided further that the total cost of the
 21 projects thus combined shall not exceed the total of the sums
 22 specified for the projects separately. The amount after each cost
 23 element and the total funding for each project listed in this part is
 24 in thousands of dollars.

2 SECTION 4. Act 133, Session Laws of Hawaii 2013, is
3 amended by amending part V to read as follows:

4 "PART V. ISSUANCE OF BONDS

5 SECTION 8. General obligation bonds may be issued, as
6 provided by law, to yield the amount that may be necessary to
7 finance projects authorized in part II and listed in part IV of
8 this Act; provided that the sum total of the general obligation
9 bonds so issued shall not exceed [~~\$14,825,000.~~] \$104,015,000."

10 SECTION 5. If any portion of this Act or its application
11 to any person or circumstances is held to be invalid for any
12 reason, the remainder of the Act and any provision thereof shall
13 not be affected. If any portion of a specific appropriation is
14 held to be invalid for any reason, the remaining portion shall
15 be independent of the invalid portion and shall be expended to
16 fulfill the objective and intent of the appropriation to the
17 extent possible.

18 SECTION 6. If any manifest clerical, typographical, or
19 other mechanical error is found in this Act, the chief justice
20 is authorized to correct the error. All changes made pursuant
21 to this section shall be reported to the legislature at its next
22 regular session.

23 SECTION 7. Statutory material to be repealed is bracketed

2 SECTION 8. This Act shall take effect on July 1, 2014.
