A BILL FOR AN ACT

RELATING TO HIGHER EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII: 1 SECTION 1. The legislature finds that the University of 2 Hawaii system currently has a backlog of deferred repair and maintenance projects totaling over \$480,000,000. 3 4 complying with building code and health and safety requirements across all campuses of the University of Hawaii system will cost 5 6 over \$38,000,000 in fiscal year 2014-2015. These costs do not 7 include the additional \$50,000,000 to \$60,000,000 in repair and 8 maintenance costs necessary to maintain all of the university 9 campuses yearly. The legislature further finds that eighty-five thousand 10 students use facilities at university campuses system-wide. 11 12 is essential to the future of the University of Hawaii and its students and faculty that a safe and proper learning environment 13 be provided and maintained. 14 The legislature declares that the backlog of deferred 15 16 repair and maintenance projects of the University of Hawaii

system is a matter of statewide concern and therefore subject to 17

the purview of the legislature pursuant to article X, section 6, 18



- 1 of the Hawaii State Constitution. Accordingly, the purpose of
- 2 this Act is to establish a means to manage the funding of
- 3 necessary repair and maintenance projects at University of
- 4 Hawaii campuses statewide.
- 5 SECTION 2. Chapter 304A, Hawaii Revised Statutes, is
- 6 amended by adding a new section to part VI, to be appropriately
- 7 designated and to read:
- 8 "\$304A- Campus facility board; established. (a) There
- 9 is established within the University of Hawaii a campus facility
- 10 board that shall consist of the following members: chancellors
- 11 from each campus of the university or the chancellor's designee,
- 12 the chairperson of the University of Hawaii board of regents
- 13 standing committee on budget and finance, and the chairperson of
- 14 the University of Hawaii board of regents standing committee on
- 15 planning and facilities.
- 16 (b) The chair of the campus facility board shall be
- 17 selected by and from among its members.
- (c) The campus facility board shall evaluate and identify
- 19 all amounts appropriated by the legislature for repair and
- 20 maintenance and shall evaluate, identify, prioritize, and
- 21 allocate moneys from the amounts appropriated by the legislature

1	detailing all projects over \$5,000,000 that were
2	delayed or experienced cost overruns; and
3	(8) The overall state of campus facilities."
