A BILL FOR AN ACT

RELATING TO CIVIL AIR PATROL.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. Conceived in the 1930s, the Civil Air Patrol is 1 a congressionally chartered, federally supported nonprofit 2 3 corporation that serves as the official civilian auxiliary of 4 the United States Air Force. While the Civil Air Patrol has 5 three congressionally mandated missions including emergency services, aerospace education, and cadet programs, it also has 6 7 begun providing other vital services such as assisting with 8 homeland security and working with law enforcement against drug-9 trafficking operations. 10 However, the Civil Air Patrol is most well-known for its work in the area of emergency services including search and 11 12 rescue missions, providing disaster relief, and in Hawaii, 13 providing tsunami warnings to coastal areas and remote 14 locations. 15 Although funding for Civil Air Patrol activities in Hawaii comes from a variety of sources, including the National Civil

- 17 SECTION 3. This Act shall take effect on July 1, 2030.
