BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 21 jurisdiction or supervision, whom designated school personnel
- 22 believes in good faith is experiencing anaphylaxis.

- 1 (b) A school may maintain a stock supply of auto-
- 2 injectable epinephrine for use in the pilot program. The school
- 3 shall store the auto-injectable epinephrine supplies in a secure
- 4 but accessible location.
- 5 (c) An authorized health care provider may prescribe auto-
- 6 injectable epinephrine in the name of a school participating in
- 7 the pilot program, and pharmacists and authorized health care
- 8 providers may dispense auto-injectable epinephrine pursuant to a
- 9 prescription issued pursuant to this section.
- (d) Any department of education employee or agent may,
- 11 upon completion of instruction described in subsection (e), use
- 12 auto-injectable epinephrine prescribed pursuant to subsection
- 13 (c) to administer auto-injectable epinephrine to any student or
- 14 other individual on school premises, at school-sponsored events,
- 15 or at any other time the student or individual is subject to the
- 16 school's jurisdiction or supervision, whom designated school
- 17 personnel believes in good faith is experiencing anaphylaxis,
- 18 regardless of whether the student or other individual has a
- 19 prescription for auto-injectable epinephrine specific to the
- 20 student on file with the school pursuant to section 302A-1164,
- 21 Hawaii Revised Statutes, or has previously been diagnosed with
- 22 an allergy.

- 1 (e) Any employee or agent of the department of education
- 2 who volunteers as part of the pilot program to administer auto-
- 3 injectable epinephrine in an emergency situation to a person
- 4 experiencing anaphylaxis shall receive instruction in the proper
- 5 administration of auto-injectable epinephrine by a qualified
- 6 health care professional. For the purposes of this subsection,
- 7 a "qualified health care professional" means a licensed
- 8 physician, physician assistant, advanced practice registered
- 9 nurse or registered nurse, or certified diabetes educator.
- 10 (f) Any person who acts in accordance with the
- 11 requirements of the pilot program shall be immune from any civil
- 12 or criminal liability arising from these acts, except where the
- 13 person's conduct would constitute gross negligence, wilful and
- 14 wanton misconduct, or intentional misconduct.
- 15 SECTION 3. The department of education, in collaboration
- 16 with the department of health, shall report findings and
- 17 recommendations, including any proposed legislation, regarding
- 18 the pilot program to the legislature no later than twenty days
- 19 prior to the convening of the regular sessions of 2016 through
- 20 2021.
- 21 SECTION 4. There is appropriated out of the general

Department of Education; Department of Health; Administration of Auto-injectable Epinephrine; Appropriation

Description:

Authorizes Department of Education employees and agents with specified training to volunteer to administer auto-injectable epinephrine to a student with anaphylaxis. Allows the Department of Education to make arrangements to receive auto-injectable epinephrine supplies from manufacturers and suppliers. Establishes a five-year auto-injectable epinephrine pilot program within the Department of Education. Requires reports to the Legislature. Makes an appropriation. Effective July 1, 2030. (SD1)
