A BILL FOR AN ACT

RELATING TO CHILD SUPPORT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the family court may 2 order child support payments to continue until age twenty-three 3 if the child remains a full-time student and meets specified 4 criteria. However, after an eighteen-year-old adult child 5 demonstrates enrollment in a post-high school university, 6 college, or vocational school, the child support enforcement 7 agency does not thereafter periodically verify that the child has remained a student in good standing or completed the full-8 9 time course of study. 10 The purpose of this Act is to relieve non-custodial parents 11 of the obligation to provide post-secondary educational child 12 support if the adult child is no longer pursuing an education. 13 Section 576E-14, Hawaii Revised Statutes, is 14 amended by amending subsection (f) to read as follows: 15 In those cases where child support payments are to

- 1 support payments may be automatically suspended by the child
- 2 support enforcement agency upon the [child-reaching the age of
- 3 mineteen years.] child's next birthday. In addition, if
- 4 applicable, the agency or hearings officer may issue an order
- 5 terminating existing assignments against the responsible
- 6 parent's income and income assignment orders.
- 7 For purposes of this section, the term "semester" shall

- 11 SECTION 3. This Act shall apply to child support awards
- 12 existing on and executed after the effective date of this Act.
- 13 SECTION 4. The child support enforcement agency
- 14 established pursuant to section 576D-2, Hawaii Revised Statutes,
- 15 shall apply and enforce the additional enrollment, satisfactory
- 16 coursework completion, and reporting requirements contained in
- 17 this Act to child support awards executed prior to the effective
- 18 date of this Act.
- 19 SECTION 5. Statutory material to be repealed is bracketed
- 20 and stricken. New statutory material is underscored.
- 21 SECTION 6. This Act shall take effect on July 1, 2050.
