  - (1) Require the department of education to provide seniors at each public high school with voter registration information prior to graduation and authorize the department to assist students with voter registration; and
    - (2) Require the department of human services to provide young adults in the young adult voluntary foster care program with information on voter registration and authorize the department to assist young adults in the young adult voluntary foster care program with voter



registration.

- 1 SECTION 2. Chapter 302A, Hawaii Revised Statutes, is
- 2 amended by adding a new section to be appropriately designated
- 3 and to read as follows:
- 4 "§302A- Voter registration information for seniors. The
- 5 department shall provide each senior at each public high school
- 6 with information on voter registration prior to graduation. The
- 7 department may determine the appropriate manner in which the
- 8 information shall be distributed. The department may also
- 9 assist students with voter registration."
- 10 SECTION 3. Chapter 346, Hawaii Revised Statutes, is
- 11 amended by adding a new section to part XIX to be appropriately
- 12 designated and to read as follows:
- 13 "\$346- Voter registration information; registration
- 14 assistance. The department shall provide each young adult in
- 15 the young adult voluntary foster care program with information
- 16 on voter registration but may determine the appropriate manner
- 17 in which the information shall be distributed. The department
- 18 may also assist young adults in the young adult voluntary foster
- 19 care program with voter registration."
- 20 SECTION 4. New statutory material is underscored.
- 21 SECTION 5. This Act shall take effect upon its approval.
