A BILL FOR AN ACT

RELATING TO HOMELESSNESS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Homelessness is a complex issue that requires a 2 comprehensive and collaborative approach among public, private, 3 nonprofit, and other community stakeholders to provide services 4 and resources to homeless individuals and families, and to 5 prevent homelessness. Act 279, Session Laws of Hawaii 1992, 6 established the Hale Kokua project, a two-year homeless 7 assistance pilot project within the Hawaii housing authority to 8 provide incentives and assistance to private homeowners in the 9 city and county of Honolulu who set aside existing dwelling **10** units, or construct new or improve existing dwelling units, for 11 rental for a period of five years by families or individuals 12 classified as homeless under the project. 13 Subsequently, Act 167, Session Laws of Hawaii 1998, 14 established the Hale Kokua program within the housing and 15 community development corporation of Hawaii to address the issue 16 of homelessness by providing housing and job-training for the **17** State's homeless population. This homeless assistance program 18 authorized the payment of a state grant and monthly rent



- 1 supplement to interested property owners who set aside existing
- 2 rental space or made improvements or constructed adjoining or
- 3 separate dwelling units to rent the units to families or
- 4 individuals classified as employed but homeless under the
- 5 program. The Hale Kokua program was subsequently placed under
- 6 the Hawaii public housing authority by Act 180, Session Laws of
- 7 Hawaii 2006; however, the program was later repealed by Act 89,
- 8 Session Laws of Hawaii 2010.
- 9 The legislature finds that homelessness continues to be one
- 10 of the primary challenges in the State. According to the
- 11 Homelessness Research Institute, Hawaii has the highest rate of
- 12 homeless per capita of any state with about forty-five homeless
- 13 individuals out of every ten thousand.
- 14 The purpose of this Act is to assist homeless families and
- 15 individuals in the State by establishing the Hale Kokua program
- 16 within the department of human services.
- 17 SECTION 2. Chapter 346, Hawaii Revised Statutes, is
- 18 amended by adding a new part to be appropriately designated and
- 19 to read as follows:
- 20 "PART XX. HALE KOKUA PROGRAM
- 21 §346- Definitions. As used in this part, unless the
- 22 context clearly requires otherwise:

1	"Administrator" means the state homeless section							
2	administrator.							
3	"Employed but homeless" means any person who is homeless as							
4	defined in section 346-361 and:							
5	(1) Is employed at least nineteen hours per week; or							
6	(2) Participates in an employment training program and							
7	does volunteer work for a total of nineteen hours per							
8	week until employment can be found.							
9	§346- Hale Kokua program; established. There is							
10	established, within the department, a homeless assistance							
11	program known as the Hale Kokua program, to provide incentives							
12	and assistance to homeowners throughout the State who set aside							
13	existing dwelling units for rental for a period of five years by							
14	families or individuals classified as employed but homeless;							
15	provided that the family or individual shall be:							
16	(1) Unrelated to the homeowner who sets aside any dwelling							
17	unit for rental under this part; and							
18	(2) Registered in the State of Hawaii Homeless Management							
19	Information System.							
20	The department shall administer the Hale Kokua program and adopt							
21	the standards and framework necessary to implement the program.							

The program shall be headed by the administrator.

19	(3)	Developing and adopting the requirements, which shall								
20		include a background check, qualifications, and								
21		registration procedures for property owners who								
22		provide rental housing to qualified homeless tenants;

 - (8) Monitoring the financial status and progress of homeless tenants in the program and cooperating with other agencies in establishing and coordinating job training and other programs to help tenants to progress toward self-sufficiency;
- (9) Promoting and assisting in the development of
 employer-employee relationships between homeless

2		but not limited to, tenant caretaker, housekeeper, or
3		groundskeeper employment situations;
4	(10)	Working towards seeking financial, in-kind, and
5		administrative assistance from law enforcement and
6		other state and county agencies and the private sector
7		to implement the program;
8	(11)	Working towards securing funding assistance from
9		federal agencies and programs involved in housing
10		development, job-training, or homeless assistance;
11	(12)	Monitoring the progress of the program, and collecting
12		annual statistics showing the numbers of homeless
13		persons, homeless families, and homeless children,
14		using appropriate measurement systems; and
15	(13)	Preparing recommendations to improve and expand the
16		program including but not limited to incentives for
17		participating property owners to sign up for
18		additional terms.

- 7 rental housing to any homeless tenant under this part for a
- 8 period of five years shall include at least one of the
- 9 following:
- 10 (1) The payment of a monthly state rent subsidy to
- 11 supplement the monthly rental payments made by the
- 12 homeless tenant;
- 13 (2) Real property tax rate waivers or reductions proposed
- by the department and approved by the council of the
- 15 county in which the property is located; or
- 16 (3) Other incentives consistent with the purposes of this
- part to assist in the participation of property owners
- 18 under the program.
- 19 §346- Availability of funding. All rental subsidies and
- 20 payments allocated by the program under this part shall be
- 21 subject to the availability of funds."

1	SECTION 3. There is appropriated out of the general
2	revenues of the State of Hawaii the sum of \$ or so much
3	thereof as may be necessary for fiscal year 2014-2015 to:
4	(1) Establish one full-time equivalent (1.00 FTE)
5	permanent state homeless section administrator in the
6	department of human services to head and oversee the
7	Hale Kokua program;
.8	(2) Implement the Hale Kokua program; and
9	(3) Carry out the purposes of this Act.
10	The sum appropriated shall be expended by the department of
11	human services for the purposes of this Act.
12	SECTION 4. This Act shall take effect upon its approval;
13	provided that section 3 shall take effect on July 1, 2014.
