#### A BILL FOR AN ACT

RELATING TO HOUSING.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

Ţ	PART 1
2	SECTION 1. The legislature finds that homelessness
3	continues to be one of the State's most significant and
4	challenging social problems. The legislature further finds that
5	according to a recent report from the department of human
6	services, fourteen thousand two hundred homeless individuals
7	were serviced through shelter and outreach programs in the 2011
8	fiscal year. Within this group, 9,781 homeless individuals
9	resided in the city and county of Honolulu. The legislature
10	also finds that homeless service providers estimate that six
11	thousand homeless individuals in the State need shelter every
12	night.
13	The legislature also finds that homelessness is a complex
14	issue that requires continuous resources and coordinated efforts
15	at all levels. Homeless people face many different issues,
16	including mental illness, substance abuse, loss of employment
17	and income, and a lack of affordable housing. Appropriate

- funding for programs tailored to address these issues is 1 2 essential. The purpose of this part is to better assist individuals 3 facing or experiencing homelessness by funding various homeless 4 5 and housing programs. 6 SECTION 2. There is appropriated out of the general 7 revenues of the State of Hawaii the sum of \$ or so much thereof as may be necessary for fiscal year 2014-2015 for 8 substance abuse treatment and mental health support services for 9 individuals who are homeless or at risk of becoming homeless. 10 The sum appropriated shall be expended by the department of 11 health for the purposes of this part. 12 SECTION 3. There is appropriated out of the general 13 revenues of the State of Hawaii the sum of \$ 14 or so much thereof as may be necessary for fiscal year 2014-2015 for 15 clean and sober housing support services to be administered by 16 the alcohol and drug abuse division of the department of health. 17 The sum appropriated shall be expended by the department of 18 19 health for the purposes of this part.

4	principle	s of housing first programs include:			
5	(1)	Moving chronically homeless individuals into housing

7		precondition of accepting or complying with substance			
8		abuse or mental health treatment;			
9	(2)	Providing robust support services for program			
10		participants that are predicated on assertive			
11		engagement rather than coercion;			
12	(3)	Granting chronically homeless individuals priority as			
13		program participants for housing first programs;			
14	(4)	Embracing a harm-reduction approach to addictions			
15		rather than mandating abstinence while supporting			
16	•	program participants to recovery; and			
17	(5)	Providing program participants with leases and tenant			
18		protections as provided by law.			
19	The	housing first programs in the State closely resemble			
20	the requi	rements of the United States Department of Housing and			
21	Urban Dev	elopment shelter plus care program and the Veterans			

Administration veteran's assisted supportive housing voucher

- 1 program for homeless veterans. In its December 2011 report to
- 2 the legislature, pursuant to section 346-378, Hawaii Revised
- 3 Statutes, the department of human services reported that the
- 4 State has six hundred fifty-eight permanent housing placements
- 5 plus support services through the shelter plus care and
- 6 veteran's assisted supportive housing voucher programs.
- 7 The purpose of this part is to appropriate funds to the
- 8 department of human services to support the State's housing
- 9 first programs in assisting Hawaii's chronically homeless who
- 10 are most often the most vulnerable and difficult to serve.
- 11 SECTION 6. There is appropriated out of the general
- 12 revenues of the State of Hawaii the sum of \$ or so
- 13 much thereof as may be necessary for fiscal year 2014-2015 to be
- 14 deposited to the credit of the housing first special fund,
- 15 established under section 346-377, Hawaii Revised Statutes, to
- 16 continue the administration of housing first programs for
- 17 chronically homeless individuals in the State.
- 18 SECTION 7. There is appropriated out of the housing first
- 19 special fund the State of Hawaii the sum of \$ or so
- 20 much thereof as may be necessary for fiscal year 2014-2015 for
- 21 the continued administration of the housing first programs for
- 22 chronically homeless individuals in the State.



1	The sum appropriated shall be expended by the department of
2	human services for the purposes of this part.
3	PART IV
4	SECTION 8. The legislature finds that the purpose of the
5	United States Department of Housing and Urban Development's
6	homelessness prevention and rapid re-housing program is to
7	provide economically distressed households and individuals with
8	financial and other assistance to prevent them from becoming
9	homeless and help those who are experiencing homelessness to be
. 10	quickly re-housed and stabilized. The funds under this program
11	were intended to target individuals and families who would be
12	homeless but for this assistance.
13	The department of human services administers the
14	homelessness prevention and rapid re-housing program to provide
15	homeless prevention and housing assistance to all eligible
16	individuals and households who apply through contracted
17	organizations. The funds from the program provide a variety of
18	assistance, including short-term or medium-term rental
19	assistance, housing relocation and stabilization services, such
20	as mediation, security or utility deposits, utility payments,
21	moving cost assistance, and case management.

The purpose of this part is to appropriate funds to the 1 department of human services to provide homelessness prevention 2 3 and rapid re-housing assistance to all eligible individuals and 4 households. 5 SECTION 9. There is appropriated out of the general 6 revenues of the State of Hawaii the sum of \$ or so much thereof as may be necessary for fiscal year 2014-2015 for 7 the homelessness prevention and rapid re-housing program. 8 9 The sum appropriated shall be expended by the department of human services for the purposes of this part. 10 11 PART V 12 SECTION 10. The shelter plus care program of the United 13 States Department of Housing and Urban Development provides rental assistance in connection with other supportive services. 14 15 The program provides a variety of permanent housing choices, accompanied by a range of supportive services funded through 16 17 other sources. The program assists hard-to-serve homeless individuals with disabilities and their families. 18 19 individuals primarily include those with serious mental illness,

chronic problems with alcohol and drugs, HIV, AIDS, or related

diseases.

20

There are four components to the shelter plus care program: 1 2 single room occupancy component - moderate rehabilitation for single-room occupancy dwellings; sponsor-based rental assistance 3 component; project-based rental assistance component; and 4 5 tenant-based rental assistance component. Under all components, supportive services must be available to meet the needs of participants. Similar to many other federal programs, the 7 shelter plus care program has a match requirement. 8 applicants must match the aggregate amount of shelter plus care 9 rental assistance with supportive services. This ensures that 10 appropriate and timely services will be available to meet the 11 needs of individual participants. 12 The purpose of this part is to provide matching funds for 13 14 the shelter plus care program. SECTION 11. There is appropriated out of the general 15 revenues of the State of Hawaii the sum of \$ or so 16 much thereof as may be necessary for fiscal year 2014-2015 for 17 matching funds for the shelter plus care program of the United 18 States Department of Housing and Urban Development. 19 The sum appropriated shall be expended by the department of 20

1 The legislature finds that many homeless SECTION 12. 2 persons are known to thrive better when they have ready access 3 to familiar support groups or family members. In light of this finding, the legislature enacted Act 222, Session Laws of Hawaii 4 5 2013, which in part authorized the department of human services 6 to establish a return-to-home program. The intent of the 7 return-to-home program is to ensure that those individuals who 8 find themselves homeless in the islands are able to reconnect with support networks ready and able to receive them. 9 10 The purpose of this part is to require the department of 11 human services to establish a three-year return-to-home program 12 for eligible homeless individuals. SECTION 13. Act 222, Session Laws of Hawaii 2013, is 13 14 amended by amending section 13 to read as follows: "SECTION 13. (a) The department of human services [may] 15 shall coordinate a voluntary homeless assistance pilot program 16 17 to be known as the return-to-home pilot program to provide 18 eligible homeless individuals with assistance in being reunited 19 with family and relatives in the individual's home state. 20 department [may] shall contract with eligible non-profit 21 organizations, for profit organizations, or foundations to

administer the pilot program.

1	(b)	No	individual	who	is	homeless	shall	be	eligible	to

- 2 participate in the return-to-home pilot program unless:
- 3 (1) The individual's participation is completely
- 4 voluntary;
- 5 (2) The individual, if on parole, probation, or awaiting a
- 6 court hearing or sentencing, has proper clearance from
- 7 the court to participate in the pilot program; and
- 8 (3) The individual is indigent and lacks the financial
- 9 resources necessary to secure transportation to return
- 10 to the individual's home state.
- 11 (c) An individual shall participate in the return-to-home
- 12 pilot program only once and shall sign an agreement to this
- 13 effect before participating in the pilot program. The agreement
- 14 shall be kept on file with the pilot program.
- 15 (d) The return-to-home pilot program shall actively seek
- 16 the participation of local airlines, cruise lines, charter
- 17 companies, homeless programs, travel agencies, and the visitor
- 18 industry to coordinate and implement the pilot program.
- 19 (e) The return-to-home pilot program shall assist program
- 20 participants with necessary and proper preparations for travel,
- 21 including obtaining proper identification, accessing public

- 1 transportation to the airport, providing orientation relating to
- 2 airport security, and ensuring sufficient personal hygiene.
- 3 (f) The return-to-home pilot program shall cease to exist
- 4 on December 31, [2016.] 2017."
- 5 SECTION 14. There is appropriated out of the general
- 6 revenues of the State of Hawaii the sum of \$ or so
- 7 much thereof as may be necessary for fiscal year 2014-2015 for
- 8 implementation of the return-to-home pilot program, including
- 9 all program costs and hiring of necessary staff.
- 10 The sum appropriated shall be expended by the department of
- 11 human services for the purposes of this part.
- 12 PART VII
- 13 SECTION 15. The legislature finds that homelessness
- 14 continues to be one of the State's most significant and
- 15 challenging social problems. The number of homeless persons in
- 16 the State, estimated to be approximately six thousand on any
- 17 given day, is indicative of the limited shelter space available.
- 18 The legislature further finds that new and innovative
- 19 solutions are needed to address the homelessness crisis.
- 20 Oregon, for example, has adopted laws that authorize political
- 21 subdivisions to allow religious institutions to offer overnight
- 22 camping space for homeless persons living in vehicles.



- 1 Similarly, Santa Barbara, California, has instituted a program
- 2 that allows private organizations to use county-owned parking
- 3 lots to provide overnight sleeping space for homeless persons
- 4 with vehicles.
- 5 Act 222, Session Laws of Hawaii 2013, established a
- 6 homeless assistance working group to work within each local
- 7 neighborhood in each county to identify, plan, and implement
- 8 housing options for homeless individuals in each local community
- 9 that reflects shared responsibility for addressing homelessness
- 10 in Hawaii.
- 11 The purpose of this part is to appropriate funds for the
- 12 construction and demonstration of housing solutions related to
- 13 the finding and recommendations of the homeless assistance
- 14 working group.
- 15 SECTION 16. There is appropriated out of the general
- 16 revenues of the State of Hawaii the sum of \$ or so
- 17 much thereof as may be necessary for fiscal year 2014-2015 for
- 18 the construction and demonstration of innovative temporary
- 19 housing solutions as they relate to the homeless assistance
- 20 working group's findings and recommendations.
- 21 The sum appropriated shall be expended by the department of
- 22 human services for the purposes of this Act.
