A BILL FOR AN ACT

RELATING TO INSURANCE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the accessibility
- 2 and affordability of proper dental services is a continuing
- 3 problem in this State. The lack of good dental care can lead to
- 4 other more serious health problems, ultimately resulting in
- 5 higher medical costs and deteriorating health conditions. While
- 6 access is not a problem unique to Hawaii, it is imperative that
- 7 solutions be adopted and implemented in order to prevent further
- 8 decline.
- 9 One way to improve access to dental care is to give
- 10 patients the option of going to their practitioner of choice --
- 11 the dentist that they know and trust. Currently, this is not
- 12 possible if that dentist is not a participant in the patient's
- 13 health insurance plan. Often under such circumstances, the
- 14 patient would have to pay the dentist first and wait to receive
- 15 reimbursement from the insurer. In most cases, the amount
- 16 reimbursed is less than the amount that would have been paid if
- 17 the dentist was a participating dentist.

- 1 The situation becomes even more critical when a patient 2 needs to be seen by a specialist, especially in an emergency, but is limited to seeing only a specialist who is a participant 3 in that patient's health insurance plan. This requirement can 4 result in delays, additional pain and discomfort, and increased 5 6 risk to the patient. 7 The purpose of this Act is to enhance the patient's access 8 to quality dental care, without increasing costs to the insurer 9 or the patient, by permitting patients to select their dentists 10 and allowing patients the option of having their insurance reimbursement sent directly to the dentist of choice. 11 12 SECTION 2. Chapter 431, Hawaii Revised Statutes, is amended by adding a new section to article 10A to be 13 14 appropriately designated and to read as follows: 15 "§431:10A- Dental services; reimbursement. (a) An insured may assign reimbursement for dental services directly to 16 17 the provider of services. (b) Upon notification by the insured, the insurer shall 18 19 reimburse the provider for dental services provided to the 20 insured, regardless of whether the provider is a

nonparticipating provider with the insurer.

(c) Nothing in this section shall be construed to affect 1 2 any other contract provision between an insurer and a dentist, 3 including any differential in reimbursement between participating and nonparticipating providers. 4 5 (d) As used in this section: "Participating provider" means a provider that contracts 6 7 with an insurer to provide services to insureds. "Provider" means a dentist licensed to practice in Hawaii 8 9 under chapter 448." 10 SECTION 3. Chapter 432, Hawaii Revised Statutes, is amended by adding a new section to article 1 to be appropriately 11 designated and to read as follows: 12 "§432:1- Dental services; reimbursement. (a) An 13 insured may assign reimbursement for dental services directly to 14 15 the provider of services. (b) Upon notification by the insured, the insurer shall 16 reimburse the provider for dental services provided to the 17 insured, regardless of whether the provider is a 18 19 nonparticipating provider with the insurer. (c) Nothing in this section shall be construed to affect 20

any other contract provision between an insurer and a dentist,

1 including any differential in reimbursement between 2 participating and nonparticipating providers. 3 (d) As used in this section: "Participating provider" means a provider that contracts 4 5 with an insurer to provide services to insureds. "Provider" means a dentist licensed to practice in Hawaii 6 7 under chapter 448." 8 SECTION 4. Chapter 432D, Hawaii Revised Statutes, is 9 amended by adding a new section to be appropriately designated 10 and to read as follows: "\$432D- Dental services; reimbursement. (a) An 11 insured may assign reimbursement for dental services directly to 12 the provider of services. 13 (b) Upon notification by the insured, the dental insurer 14 15 shall reimburse the provider for dental services provided to the insured. The dental insurer shall reimburse the provider 16 regardless of whether the provider is a participating provider 17 18 with the dental insurer. **19** (c) Nothing in this section shall be construed to affect any other contract provision between a dental insurer and a 20 dentist, including any differential in reimbursement between 21

participating and nonparticipating providers.

(d) Notwithstanding any law to the contrary, as used in 1 2 this section: "Participating provider" means a provider that contracts 3 with an insurer to provide services to insureds. 4 "Provider" means a dentist licensed to practice in Hawaii 5 6 under chapter 488." SECTION 5. Section 432D-23, Hawaii Revised Statutes, is 7 8 amended to read as follows: 9 "§432D-23 Required provisions and benefits. 10 Notwithstanding any provision of law to the contrary, each policy, contract, plan, or agreement issued in the State after 11 January 1, 1995, by health maintenance organizations pursuant to 12 13 this chapter, shall include benefits provided in sections 431:10-212, 431:10A-115, 431:10A-115.5, 431:10A-116, 431:10A-14 15 116.5, 431:10A-116.6, 431:10A-119, 431:10A-120, 431:10A-121, 431:10A-125, 431:10A-126, 431:10A-122, 431:10A- , and 431:10A-16 17 116.2, and chapter 431M."
