A BILL FOR AN ACT

RELATING TO A CAR-SHARING VEHICLE SURCHARGE TAX.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that car-sharing is a 2 green transportation innovation that can significantly reduce 3 vehicle miles traveled, oil imports, greenhouse gas emissions, 4 and household transportation costs for Hawaii residents. Car-5 sharing is a fairly new transportation innovation in the United 6 States that has emerged only in the last ten years. Unlike 7 traditional car rentals, car-sharing is not aimed at tourists or 8 individuals who are getting a personal vehicle repaired. Car-

9 sharing is rented by the minute or by the hour, rather than by

10 the day. Car-sharing members are persons who either cannot

11 afford to or prefer not to own their own vehicles but

12 occasionally need access to vehicles to run errands. Car-

13 sharing enables them to enjoy the benefits of automobile access

14 without the high fixed costs and other concerns that come with

15 car ownership.

16 The purpose of this Act is to create a car-sharing vehicle

17 surcharge tax.

1 SECTION 2. Chapter 251, Hawaii Revised Statutes, is 2 amended by adding a new section to be appropriately designated 3 and to read as follows: 4 "§251- Car-sharing vehicle surcharge tax. There is 5 levied and shall be assessed and collected a car-sharing vehicle 6 surcharge tax of \$ per day for each vehicle available 7 for use or partially available for use during each month by 8 members of a car-sharing organization. The car-sharing vehicle 9 surcharge tax shall be levied upon the car-sharing 10 organization." 11 SECTION 3. Chapter 251, Hawaii Revised Statutes, is 12 amended by amending its title to read as follows: "[+]CHAPTER 251[+] 13 14 RENTAL MOTOR VEHICLE [AND], TOUR VEHICLE, AND CAR-SHARING 15 VEHICLE SURCHARGE TAX" **16** SECTION 4. Section 251-1, Hawaii Revised Statutes, is 17 amended by adding a new definition to be appropriately inserted 18 and to read as follows: 19 ""Car-sharing organization" means an organization that 20 operates a membership program in which: 21 (1) Self-service access to a fleet of vehicles is 22 provided, with or without requiring a reservation,

3	(2)	Members are charged a usage rate, either hourly or by
4		the minute, for each use of a vehicle;
5	<u>(3)</u>	Members are not required to enter into a separate

8	(4)	The average paid use period for all vehicles provided
9		by the organization during any calendar year is four

11	SECTION 5. Section 251-3, Hawaii Revised Statutes, is	
12	amended by amending subsection (a) to read as follows:	
13	"(a)	Each person as a condition precedent to engaging or
14	continuing in the business of providing rental motor vehicles to	
15	the public or engaging or continuing in the tour vehicle	
16	operator business or a car-sharing organization business shall	
17	register with the director. A person required to so register	
18	shall mak	e a one-time payment of \$20, upon receipt of which the
19	director	shall issue a certificate of registration in such form
20	as the di	rector determines, attesting that the registration has
21	been made. The registration shall not be transferable and shall	
22	be valid	only for the person in whose name it is issued and for
