A BILL FOR AN ACT

RELATING TO PUBLIC LANDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that historic property is a unique and irreplaceable public trust resource. 2 The 3 legislature further finds that chapter 171, Hawaii Revised 4 Statutes, fails to provide guidance with respect to public land 5 involving historic property. The State, as trustee of the 6 public trust assets, including those related to historic 7 property, has duties greater than that of a business manager, 8 and must take into consideration that the "beneficiaries of the 9 public trust are not just present generations but those to 10 come." In re Waiola O Molokai, 103 Hawaii'i 401, 421-22, 83 11 P.3d 664, 684-85 (2004).

12 The purpose of this Act is to establish guidelines to be 13 met by the State before it conveys, transfers, or exchanges an 14 interest in public land involving historic property.

15 SECTION 2. Section 6E-7, Hawaii Revised Statutes, is16 amended by amending subsection (b) to read as follows:

17 "(b) The department may [dispose of the historic property]

18 convey, transfer, or exchange any interest in:

18	consultation with the state historic preservation division and
19	reviewed under section 6E-8 and its implementing regulations.
20	The department shall determine the conditions for any research
21	affecting the historic property and may issue permits for the
22	research."
