A BILL FOR AN ACT

RELATING TO HISTORIC PRESERVATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the state historic 2 preservation officer's duties, pursuant to the National Historic 3 Preservation Act, as amended, 16 United States Code section 470, 4 et seq., include reviewing nominations for the National Register 5 of Historic Places and maintaining data on historic places in 6 Hawaii that have not yet been nominated for the National 7 Register of Historic Places. Pursuant to the National Historic 8 Preservation Act, the state historic preservation officer also 9 serves as the State's consultant to federal agencies regarding 10 their historic preservation responsibilities in Hawaii including 11 determining the impact of federal agency undertakings on 12 properties that are listed on or eligible for listing on the 13 National Register of Historic Places. Federal agencies also 14 consult with the appropriate state historic preservation officer 15 during their identification of historic properties and their 16 assessment of the effect of an undertaking on a historic 17 property.

- 1 Due to the important role that the state historic
- 2 preservation officer serves with regard to federal and state
- 3 historic preservation matters, the legislature in 1976 required
- 4 the Hawaii state historic preservation officer to be appointed
- 5 on the basis of professional competence and experience in the
- 6 field of historic preservation. The legislature finds that
- 7 these broadly worded qualifications should be clarified and that
- 8 this appointment should be based on nationally accepted and
- 9 applied professional standards that will bring greater
- 10 accountability and consistency to the appointment of the Hawaii
- 11 state historic preservation officer.
- 12 The purpose of this Act is to strengthen the state historic
- 13 preservation division by requiring that the state historic
- 14 preservation officer meet the required professional
- 15 qualification standards established by the United States
- 16 Secretary of the Interior and by converting certain positions
- 17 within the division to civil service status.
- 18 SECTION 2. Section 6E-3, Hawaii Revised Statutes, is
- 19 amended to read as follows:

17		complexity of the projects or services provided, and

1	(1) Be a qualified historic preservation professional in
2	architecture, architectural history, archaeology,
3	history, Hawaiian studies, or a closely related field,
4	who meets the professional qualification standards
5	established by the United States Secretary of the
6	Interior; and
7	(2) Have professional experience with respect to historic
8	preservation in Hawaii.
9	(c) The state historic preservation officer shall be the
10	administrator of the state historic preservation division and
11	shall be placed in the department for the purposes of the state

20	to serve in that position."

- 2 date of this Act shall not be transferred, demoted, or otherwise
- 3 dislocated from that position solely as a consequence of this

- 5 SECTION 5. Each position exempt from chapter 76, Hawaii
- 6 Revised Statutes, assigned to the department of land and natural
- 7 resources state historic preservation division, except for the
- 8 division administrator position, shall be converted to civil
- 9 service status pursuant to chapter 76, Hawaii Revised Statutes.
- 10 Any incumbent employee of the state historic preservation
- 11 division whose position prior to this Act was exempt from civil
- 12 service shall remain in their position and be appointed to the
- 13 converted civil service position without the loss of any
- 14 vacation and sick leave credits previously earned, and other
- 15 rights, benefits, and privileges, in accordance with state
- 16 personnel laws and this Act; provided that the employee
- 17 possesses the minimum qualifications and public employment
- 18 requirements for the class or position to which appointed;
- 19 provided further that subsequent changes in status may be made
- 20 pursuant to applicable civil service and compensation laws.

- 1 SECTION 6. Statutory material to be repealed is bracketed
- 2 and stricken. New statutory material is underscored.
- 3 SECTION 7. This Act shall take effect upon its approval.
